CHAIR'S CONCLUSIONS

Meeting of the Executive Committee 31 October 2018

FORMAL SEGMENT

<u>Item 1 – Adoption of the agenda.</u>

1. The revised provisional draft agenda for the 101st meeting was adopted.

Item 2 – Chair's conclusions from the last meeting.

2. The conclusions from the $100^{\rm th}$ meeting of EXCOM (EXCOM/CONCLU/100) were adopted.

INFORMAL SEGMENT

<u>Item 3 - Repositioning of the United Nations Development system</u>

- 3. The Executive Secretary informed EXCOM that Mr. Jens Wandel had been appointed Special Advisor to the Secretary-General on Reforms. She recalled that the second phase of the reform would focus on the review of the regional assets of the UN Development System. She explained that the possible use of external consultants to carry out this review was under review at UN Headquarters on account of cost and mixed experience in the past. The latest indications she had from UN Headquarters signalled that the review may be carried out by UN staff internally. She said the discussions on the matter were ongoing and invited delegates to follow the latest developments on the website http://reform.un.org.
- 4. The Chair concluded that EXCOM thanks the secretariat for the information provided, and hopes to be kept abreast of further relevant developments.

Item 4 - Beijing +25 Regional Review Meeting

The Executive Secretary informed member States that a note had been sent to New York missions by UN Women on the preparation of national reviews on the implementation of the Beijing Declaration and Platform. She encouraged all member States to complete their national reviews by 1 May 2019. On the basis of these reviews, UNECE would prepare a regional assessment report to inform its Regional Review Meeting. The meeting would review the progress and challenges in the twelve areas of concern of the Beijing Platform for Action, and in achieving gender equality in the broader context of sustainable development. It was planned to be a multi-stakeholder event taking place in the Palais des Nations on 29 and 30 October 2019. UNECE would work closely with relevant entities of the regional UN system and other partners in organizing this event. The outcome of the meeting would be a Chairperson's conclusions, which would serve, together with the regional review report, as UNECE's regional input into the global review meeting. UNECE would will need extrabudgetary resources on the order of about 60,000 USD to finance speakers, consultants for the regional assessment report and background notes, and to cover the travel costs of speakers and participants from Eastern Europe, Caucasus and Central Asia. The Executive Secretary encouraged all countries interested in making a contribution to contact the secretariat.

6. The Chair concluded that EXCOM decides for UNECE to hold a regional review meeting for Beijing+25, in line with ECOSOC resolution E/RES/2018/8 and in accordance with its respective mandates, subject to availability of resources. EXCOM requests the secretariat to submit an extrabudgetary proposal for approval by EXCOM at its 102nd session, and to regularly update EXCOM on the preparations for the review meeting.

Item 5 - Important new developments: briefing by the Executive Secretary

- 7. The Executive Secretary informed EXCOM about a Memorandum of Understanding (MoUs) planned with the Institute of Comprehensive Exploitation of Mineral Resources of the Russian Academy of Science. The purpose of the MoU was to provide a framework for setting up and running an International Centre of Excellence on Coal Mine Methane in the Russian Federation, to operate under the auspices of the UNECE Group of Experts on Coal Mine Methane.

- 14. The Chair informed EXCOM that a UN/CEFACT contact group meeting would take place on 6 December in Room S1.
- 15. The Chair informed EXCOM that the next meeting would be held on 14 December 2018.
- 16. The Executive Secretary recalled that the Deputy Executive Secretary was on medical leave and said that she was exploring options to temporarily fill the position during his absence. She noted UNECE's difficulty in financing such an arrangement and encouraged member States to contact her in case of interest.
