Dear Mr. Tarasenko,

I am writing to you on behalf of the Implementation Committee under the Convention on Environmental Impact Assessment in a Transboundary Context (Espoo, 1991).

At its thirty-first session, held in Geneva from 2 to 4 September 2014, the Committee recalled that decision VI/2 of the Meeting of the Parties requested Ukraine to undertake a number of measures to bring the Danube-Black Sea Deep Water Navigation Canal in the Ukrainian sector of the Danube Delta and its legislation into compliance with the Convention; as well as to report by the end of each year to the Committee on how it implemented these recommendations of the Meeting of the Parties.

You are now invited to submit the report, as requested by the MOP, in English to the secretariat by no later than **21 November 2014**, for the Committee to consider at its next session.
