Dear Michael,

I have spoken to Paul McDonald, Principal Officer, Radiation Protection Policy Unit, who advises that the letter from the UK in July of this year did not amount to an invitation to the Irish Government to facilitate Irish citizens to comment on the development of HPC as you claim but rather provides an opportunity to comment on current environmental information in relation to potential trans boundary impacts using scientific evidence. A submission on those lines will be made later this week.

He advises also that there has been a satisfactory level of information received from the UK Government in relation to the development of HPC including a recent visit by DCCAE and EPA officials to the site at Hinkley.
