Subject FW: REMINDER: Letter from the Chair of the Bureau of the Meeting of the Parties to the Espoo Convention

Dear Mr Bonvoisin,

Here is the Hungarian answer for the Bureau's letter:

Please be informed, that an official list of civil societies and non-governmental organizations does not exist in Hungary (the Government does not have obligation to administer it). However, according to the Governmental Decree No. 187/2009 (came into force 1 October 2009) a public electronic database has been established to promote the participation of the interest group associations and non-governmental organizations (hereafter: NGOs) in the administrative procedures. Any NGO can apply to be registered in the database on the website http://nevjegyzek.magyarorszag.hu. If they do it so they will be notified of the start of the administrative procedures in which they would like to be a client (would like to receive legal standing) provided that they meet the requirements of the client position. In case of the environmental NGOs the Environmental Act provides for the client position of such NGOs. For the registration the NGOs have to specify their name, registration number, functional area, name of the focal person and their e-mail address.
