

**List of domestic and transboundary strategic environmental assessment procedures
according to the United Nations Economic Commission for Europe
Protocol on Strategic Environmental Assessment (Kyiv, 2003) to the Convention on Environmental Impact Assessment in a Transboundary Context (Espoo, 1991)**

The list below presents projects included in the answers to the questionnaires submitted by Parties during the first review of implementation with the Protocol (start 2010 to end 2012, questions 31 to 44). It is put on the web site at the request of the Meeting of the Parties to the Convention serving as the Meeting of the Parties to the Protocol at its second session (decision I/1 on reporting and review of implementation of the Protocol, Geneva, 2–5 June 2014).

The information is unofficial and may be incomplete, but provides an indication of practical application of the Protocol during the period 2010-2012, as presented by Parties in their answers to the questionnaire.
