Re: Communication to the Aarhus Convention Compliance Committee concerning compliance by Belarus with provisions of the Convention in connection with the proposed construction of a nuclear power plant (Ref. ACCC/C/2009/44)

With reference to our letter dated 18 December 2009, in order to facilitate further consideration of the communication, the Committee has requested the secretariat to invite you to address a number of questions that are annexed to this letter. Please provide any supplementary documentation which is necessary to substantiate your response to the above questions. At the same time, you are encouraged to avoid submitting to the Committee excessive documentation which is not strictly relevant to the allegation of non-compliance.

In a letter to the communicant, a copy of which is attached for your information, the Committee has invited the communicant to address other questions. You are welcome to respond to those questions, if you so wish.

We also remind you that, in providing your response pursuant to paragraph 23 of the annex to decision I/7, you should also explicitly comment on the communication itself and the allegations contained therein, as well as addressing the questions raised by the Committee to you (and to the communicant, if you so wish).

At our letter of 18 December 2009, you were advised to submit to the Committee your response to the allegations contained in the communication at issue within five months of the date of that later, namely by 18 May 2010. Since the Committee has now decided to invite you to address additional questions, and taking into account the fact that for practical reasons the Committee will in any case not be able to enter substantive discussions on the communication until its twenty-ninth meeting (21-24 September 2010), please note that your response to the allegations contained in the communication and to the additional questions in the annex to this letter may be provided to the Committee past the initial deadline of 18 May 2010, but no later than 31 July 2010.
