Poverty situation in 2013

- ▶ The poor's' number \cong 967 thousand
- ▶ The more poor's number from their \cong 402 thousand,
- ▶ The extremely poor's number \cong 82 thousand
- ▶ The poverty gap: 5.9%, 2012– 5.6% (increase –0.3 % point)
- ▶ The severity of poverty 1.7 %: 2012 – 1.6 % (increase– 0.1 % point)

Poverty in 2012–2013 most vulnerable groups

- **Children poverty: 36.2% –37.3%**
- **Families where the woman is the head, with 6 years old child: 42.7 % – 50.3%**

Poverty multivariate assessment –2013

- ▶ **Education**
- ▶ **Health**
- ▶ **Labor**
- ▶ **Housing conditions**
- ▶ **Consumption according to the extremely poverty line**
- ▶ **Other measurements**

State support program

- ▶ 2003 orphanage graduates and children without parental care registration
- ▶ 2006 –2008 – housing provision
- ▶ 2012–2013 – new policy development
- ▶ 01.08.2013 RA Government Decree N894–N
- ▶ 2012–2015 Housing allocation, beneficiary registration and providing housing

Who can be registered?

- ▶ **Children without parental care**
- ▶ **Socially vulnerable families**
- ▶ **Single pensioners**
- ▶ **Families with one parent**
- ▶ **Supporting family: family having a child**

Other obligatory conditions

- ▶ **Not having a living space with ownership right**
- ▶ **Absence of alienation fact of real estate during last 5 years**
- ▶ **One possibility to refuse the dwelling**
- ▶ **Existence of self-service abilities**

Living conditions

- ▶ Provision of housing and other social services
- ▶ By contract
- ▶ free
- ▶ With deadline of 5–10 years
- ▶ After deadline expiration by leasing principle – 2016

Registered (waiting list)	
Orphanage graduates	227
Children without parental care	111
Socially vulnerable family	23
