CIRCULAR LETTER No 04 - Geneva, 24 August 2020

Oman: Oman National Transport Company (Sinyar/099; formerly Mwasalat), as the issuing and guaranteeing association for TIR carnets in Oman, will begin its TIR issuing and guaranteeing activities from 27 August 2020

Addressees: TIR Carnet issuing and guaranteeing Associations

We are pleased to inform you that the "**Oman National Transport Company**" (Sinyar – formerly Mwasalat) that has been designated by the competent authorities of the Sultanate of Oman as the issuing and guaranteeing association for TIR carnets on its territory in conformity with article 6 and Annex 9, part I of the TIR Convention, will start its issuing and guaranteeing activities on 27 August 2020.

Following the approval of the IRU competent body, Sinyar became an associate member of IRU and underwent a thorough TIR admission process, which was accomplished with success.

The International Insurers have confirmed that the guarantee will be provided for both TIR carnets issued by Sinyar and TIR carnets issued by other TIR issuing associations affiliated to IRU and used on the territory of Oman.

Under the terms of Article 8.3 of the TIR Convention, the maximum sum per TIR carnet in Oman has been set at EUR 100,000.

Thus, Oman will be considered a country in which TIR transports can be arranged as of 27 August 2020.

The activation of the TIR system in Oman brings the number of TIR operational countries to 64.
