

2. Matters of interest since the last session

(a) UNECE and subsidiary bodies

The secretariat will inform delegates about the decisions that might be taken by the UNECE governing bodies having an impact on the work of the Specialized Section.

The Specialized Section will decide on keeping or removing the reference to "United Nations Economic Commission for Europe" at the top of the cover page of the standards.

3. 2009 Standard Layout

The delegations will review the use of English and French terms for different types of packages in the Standard Layout and in the standards, compare the English and the French versions of the Standard Layout to check how the English term "package" should be translated into French each time it appears in the text of the Standard Layout. The document on the definitions of different types of packaging discussed by the Working Party at its session in 2005 should be used for discussion.
