Introduction

1. The provisional agenda and time schedule for the sixth session of the Committee for Trade, Industry and Enterprise Development have been drawn up by the secretariat in consultation with the Bureau on the basis of the decisions and programme of work adopted by the Committee at its fifth session.
2. At its last session, the Committee decided to hold, in 2002, an International Forum on Trade Facilitation. A preliminary agenda for this event is attached as annex I, a more detailed version can be found in document TRADE/2002/19. The two-day Forum will be held on 29 and 30 May, between the first and last days of the Committee session (on 28 and 31 May).
3. The Committee's regular session will, therefore, formally begin on Tuesday, 28 May at 10:00. The Committee will approve the draft report of the sixth session on the afternoon of Friday, 31 May.

ANNOTATIONS

Item 1 - Adoption of the agenda

4. In accordance with the Commission's rules of procedure, the first item on the provisional agenda is the adoption of the agenda (ECE/TRADE/287).

Item 2 - Election of officers

5. At its third session, the Committee elected Mr. Alexander Safarik-Pstrosz (Czech Republic) as Chairman, and Ms. Sofia Aisagaliyeva (Kazakhstan), Ms. Ayse Öktem (Turkey) Mr. Miguel Vilchez-Barros (Spain) as its vice-chairpersons.

Item 3 - Matters arising from the fifty-seventh session of the Economic Commission for Europe

6. The secretariat will report orally on the discussions held, and the decisions adopted by the Commission at its fifty-seventh session in May 2002.

TRADE POLICY AND PROMOTION

Item 4 - Review of recent and prospective trade trends, policies and problems

7. The secretariat will introduce the latest edition of the Economic Survey of Europe (ECE/EAD/2002/2) and the extract found in ECE/TRADE/NONE/2002/1), which reviews current economic developments in the region.

A short presentation will be given on recent economic developments including foreign trade, based upon the latest edition of the Economic Survey of Europe

8. During February 2002, the secretariat prepared a background paper and organized a briefing on, “WTO, Doha and transition economies”. A member of the secretariat will present the background paper (TRADE/2002/1) which is **for noting**.

Item 5 – Follow-up to the 2001 Forum and Round Table on Trade in Services

9. The discussion will draw upon a background paper (TRADE/2002/2) prepared by the secretariat which reviews the major issues and makes suggestions as to further action that the Committee’s subsidiary bodies could take to improve trade in services in transition economies.

Item 6 – Trade promotion activities

10. The Committee will receive a report (TRADE/2002/3 and Add.1) on the Division’s multiplier point programme. The first version of the Trade Directory (TRADE/2002/4 and Add.1) and the first edition of a CD-ROM containing a wide selection of best practices information created under the Trade, Industry and Enterprise Development Programme (ECE/TRADE/284) will also be presented. All of these documents are **for noting**.

Item 7 – Topics for 2003 and 2004 forums and round tables

11. After consultation with the Bureau of the Committee, the secretariat has developed proposals for the 2003 and 2004 Forums and roundtables as found in document TRADE/2002/5, which is **for approval**.

Item 8 – Technical Harmonization and Standardization policies

12. At its June 2001 meeting, the Bureau of the Committee decided to have a more in-depth presentation from one subsidiary body at each session. It agreed that for the sixth session this presentation would be made by the Working Party on Technical Harmonization and Standardization Policies (WP.6). The Committee will also have before it the report of the 2001 session of the Working Party (TRADE/WP.6/2001/18) **for a review of any decisions the Committee has been requested to make and for endorsement**. A report on the Working Party’s activities prepared by the secretariat (TRADE/2002/6) will also be available.

REPORTS COVERING MAJOR DEVELOPMENTS AND DECISIONS REQUESTED OF THE COMMITTEE BY SUBSIDIARY BODIES AND ADVISORY GROUPS

Item 9 - Trade facilitation

13. The Committee will have before it a report from the Centre for Trade Facilitation and Electronic Business UN/CEFACT (TRADE/2002/7) summarizing developments since the Committee's last session. An oral report will also be made on decisions taken during the first day of the UN/CEFACT 2002 session which will take place immediately prior to the Committee's session (i.e. on 27 May). In addition, a brief highlights presentation will be made on: "Restructuring of the working groups under UN/CEFACT and the Centre's global mandate".

Item 10 - Agricultural quality standards

14. The Committee will have before it the report of the fifty-seventh session of the Working Party on Standardization of Perishable Produce and Quality Development (WP.7) (TRADE/WP.7/2001/9) **for a review of any decisions the Committee has been requested to make and for endorsement**, and a note by the secretariat (TRADE/2002/8) summarizing progress achieved since the November 2001 meeting of the Working Party. A brief highlights presentation will be made on: "Creating internationally harmonized quality codes for fruit and vegetables".

Item 11 – Legal and commercial practice

15. The Committee will have before it the report of the fiftieth session of the Working Party on International Legal and Commercial Practice, WP.5, (TRADE/WP.5/2002/12) **for a review of any decisions the Committee has been requested to make and for endorsement**. A brief highlights presentation will be made on: "The Public Private Partnership Alliance".

Item 12 - Industry and enterprise development

16. The Committee will have before it the report of the third session of the Working Party on Industry and Enterprise Development (TRADE/WP.8/2002/10) **for a review of any decisions the Committee has been requested to make and for endorsement**. In this report, new teams of specialists under the Working Party will be presented **for approval**. A brief highlights presentation will be made on: "Industrial restructuring in transition economies".

Item 13 - International commercial arbitration

17. The Committee will have before it a report (TRADE/2002/10) on activities of the Advisory Group on International Commercial Arbitration since the June 2001 session **for information**. A brief highlights presentation will be made on: "The importance of the 1961 European Convention on International Commercial Arbitration".

21. Under this item, the Committee will have before it a report on the activities carried out by the secretariat (TRADE/2002/14) in cooperation with other organizations including the United Nations Conference on Trade and Development (UNCTAD), the other regional commissions of the United Nations and the World Trade Organization (WTO). This report is **for noting**.

Item 17 - Activities of the Commission's other principal subsidiary bodies

22. The Committee will have before it a paper by the secretariat on trade and investment related activities of other principal subsidiary bodies (TRADE/2002/15), which includes an in-depth report on the related activities of the Timber Committee. This document is **for noting**.
