The Symposium

The United Nations, through its Centre for Trade Facilitation and Electronic Business (UN/CEFACT), will hold a three-day international Symposium to identify the tools and standards required to exchange information between Single Windows. The Symposium will also define a suitable organizational framework for drawing up the standards.

A "Single Window" is a facility that allows parties involved in trade and transport to lodge standardized information and documents with a single entry point to fulfil all import, export, and transit-related regulatory requirements¹.

The Symposium will provide participants with a unique opportunity to learn from the experiences of current Single Window operators and help identify the required standards for interoperability.

What will be covered

Day 1: Single Window Interoperability

Topics will include:

- Essential requirements
- Successful models

Day 2: Cross-border data exchange

Topics will include:

Day 3: Technical Workshop

This will be a one-day workshop for Single Window operators and other interested parties to define the standards required for Single Window Interoperability, to begin work on developing them, and define how the work should continue.

Speakers

Speakers will include Single Window operators from different continents and regions, representatives of international organizations including UN/CEFACT, the World Customs Organization and the World Bank, experts in trade facilitation trends and techniques, and representatives of industry.

Who should attend

We welcome existing and potential Single Window operators, government officials, national trade facilitation bodies, interested national and international organizations, and the business community.
