The national market surveillance authorities of the Hellenic Republic (in accordance with the requirements of Regulation (EC) No 765/2008) are listed in Table 1. The European harmonisation legislation is set out for each authority that is responsible for this legislation.

Table 2 shows the product categories in reverse order, together with the following data for each category: relevant European harmonisation legislation, transposition in national law, competent national authority for the monitoring of European legislation and transposition to national law (with the relevant contact details), and competent market surveillance authorities. Both of these tables have been included in the Market Surveillance Programme 2010, which is also submitted (in accordance with the requirements of Regulation (EC) No 765/2008).
