# I. INTRODUCTION

6. At its meeting in October 2007, the Advisory Group on Market Surveillance ("MARS" Group) agreed to start work on a model market surveillance procedure. The Working Party Bureau at its meeting in March 2008 endorsed the decision and a task force started work on this model in the spring of 2008. Panel session 1 will present the results of this work and agree on priorities for action.

At its last session, the Working Party established a Sectoral Initiative on Explosive Environments Equipment, which is tasked to agree on common regulatory objectives in this specialized sector, and to define how conformity with the agreed requirements is to be assured and demonstrated. Panel session 2 - Explosive Environments Equipment – aims to review the progress to date by the Sectoral Initiative and to set objectives for the coming months.

(c) Panel session 3 – Private Standards, jointly organized with the Working Party on Agricultural Quality Standards

- 8. Delegates at the last annual session expressed interest in exploring the issue of private standards (company specifications) and their role in a complex architecture that comprises national, regional and global standards, along with national regulations and international certification schemes.
- 9. Panel session 3 will be jointly organized with the Working Party on Agricultural Quality Standards (WP.7), in view of the importance of private standards in the agricultural and food sector, and will aim at involving the regulatory authorities, as well as private companies, in the debate.

10. Conclusions from the three panel sessions will be presented to the Working Party for consideration.

# (a) Review of developments

11. National delegations and international and regional organizations will be invited to report on their standardization and regulatory activities, as well as on technical cooperation programmes with other countries or regions. In particular, as a follow-up to the discussions held in the previous session, the European Commission will provide information on the recently adopted Common Framework for the marketing of products as well as a brief update on the implementation of the REACH (Registration, Evaluation, Authorisation and Restriction of Chemicals) Regulation.

- 12. At its seventeenth session, the Working Party approved Recommendation "M" on Use of Market Surveillance Infrastructure as a Complementary Means to Protect Consumers and Users Against Counterfeit Goods, which is submitted to delegates in its final version for information.
- 13. At its last session, the Working Party requested delegations to submit comments regarding the possible revision of Recommendation "K" on Metrological Assurance of Testing. Inputs were received from one delegation and the matter will be considered under item 9, Metrology.

14. The Working Party will receive an update on the activities developed on the basis of the UNECE Recommendation "L", International Model for Technical Harmonization based on good regulatory practice for the preparation, adoption and application of technical regulations via the use of international standards (document ECE/STAND/17/Rev.4 is also available online at <a href="http://www.unece.org/trade/wp6/major\_doc.htm">http://www.unece.org/trade/wp6/major\_doc.htm</a>).

- 15. The Working Party will be informed about the activities of its Team of Specialists on STandardization And Regulatory Techniques ("START" Team), which met in Geneva in March 2008. In accordance with UNECE Guidelines for the Establishment and Functioning of Teams of Specialists (ECE/EX/2, para. 3), the Working Party will consider extension of the mandate of the Team.
- 16. The Working Party will receive an oral report from the secretariat on the Seminar on Good Regulatory Practice, organized by the World Trade Organization in March 2008 and will be informed on potential areas for cooperation with the United Nations Centre for Trade Facilitation and Electronic Business (UN/CEFACT).

# (a) Regional projects

17. The Working Party will be informed about the status of regional projects to reinforce regulatory cooperation in the context of regional or bilateral trade agreements, especially in the Commonwealth of Independent States (CIS) and the Eurasian Economic Community (EurAsEC).

21. National delegations and international and regional organizations are invited to report on trade related aspects of conformity assessment and accreditation. International organizations are also invited to provide an update of their work on international standards, technical assistance projects, manuals and training modules.

22. The Advisory Group on Market Surveillance ("MARS" Group) will report to the Working Party on the activities of the Group and its meeting in Bratislava on 2-3 October 2008. The European Commission will present the new EU common framework for market surveillance. Finally, the secretariat will report on (a) the meeting organized jointly by the European Committee for Standardization (CEN) and the European Committee for Electrotechnical Standardization (CENELEC) on European Standards and Market Surveillance (Bucharest, 25 June 2008); and (b) the workshop on Conformity Assessment Standards in Support of Market Surveillance, organized by the ISO Council Committee on Conformity Assessment (ISO/CASCO) (29 October 2008, Geneva).
