ACTIVITIES AND ADMINISTRATION OF THE TIR EXECUTIVE BOARD (TIRExB)*

Identification (ID) number of the TIR Carnet holder and access to the International TIR Data Bank (ITDB)

Note by the secretariat

1. The ITDB contains at present almost than 40,000 persons/companies authorized by national Customs authorities to utilize the TIR procedure. It also contains information on persons excluded from the TIR procedure in accordance with Article 38 of the Convention. The requested data are provided, for the time being, only to Customs TIR Focal Points furnishing their personal user code.

2. The Administrative Committee may wish to recall, that at its previous sessions, it had urged all Contracting Parties to respect the provisions of Annex 9, Part II, paras. 4 and 5 of the Convention concerning transmission of ITDB data with a view that the ITDB becomes a value added tool for Customs authorities (TRANS/WP.30/AC.2/77, para. 15). In this context, the Committee may wish to be informed of the status of the transmission of data to the ITDB.

3. In 2005, 38 Contracting Parties (see <u>annex</u>) have complied with Annex 9, Part II, Article 5, transmitting an updated list of all authorized persons as well as of persons whose authorization has been withdrawn. 33 of them are also regularly sending information concerning

newly authorized TIR Carnet Holders as well as modifications regarding TIR Carnet Holders who have already been authorized.

4. 9 Contracting Parties have not complied in the year 2005 even if they have sent data in the previous years.

5. 4 Contracting Parties with which a TIR transit operation can be established have informed the secretariat that, for the time being, they do not have authorized TIR Carnet Holders.

6. In spite of various reminders sent by the TIR secretariat, 4 Contracting Parties have so far, not sent as of today, any information concerning their authorized TIR Carnet users.

7. Since June 2005, all authorized Customs TIR Focal Points can consult the information contained in the ITDB on line. In addition to contact information, additional information on the status of authorizations of TIR Carnet Holders are now provided. In line with the mandate by the Administrative Committee, information with regard to the exclusions imposed by Contracting Parties by virtue of Article 38 of the Convention, are for the time being not provided.

8. To further enhance the quality of the data in the ITDB, the secretariat would like to remind competent authorities to ensure that the particulars of each person authorized to use or be withdrawn from the TIR system be sent to the TIRExB within <u>one week</u> from the date of authorization or withdrawal, in accordance with Annex 9, Part II, Article 4 of the TIR Convention.
