EXPLANATORY NOTES

In accordance with Annex 7, Article 4 of the Convention, in line with the decisions taken by the Contracting Parties to the Convention at the fourth session of the Administrative Committee (18-20 October 2000) (TRANS/WP.30/AC.3/8, para.27) and at the one-hundred-and-first session of the UNECE Working Party on Customs Questions affecting Transport (WP.30) (TRANS/WP.30/202, para.19), the Executive Secretary of the UNECE is convening this fifth session of the Administrative Committee in conjunction with the one-hundred-and-third session of the UNECE Working Party (WP.30).

The UNECE Working Party (WP.30) will hold its one hundred-and-third session from 4 to 7 February 2003, starting at 10.00 hours on Tuesday, 4 February 2003 at the Palais des Nations in Geneva. As the Working Party will consider in detail the proposal for a new Annex 8 to the Convention, representatives of all Contracting Parties to the Convention are strongly recommended to participate also in this session of the Working Party. The agenda as well as

other relevant documents for the session of the Working Party may be obtained directly from the UNECE secretariat or downloaded from the relevant UNECE Transport Division web site (see page 1).

QUORUM

In accordance with Annex 7, Article 6 of the Convention, "a quorum consisting of not less than one third of the States which are Contracting Parties is required for the purposes of taking decisions." As of 1 December 2002, the number of States, Contracting Parties to the Convention is 41

1. ADOPTION OF THE AGENDA

In accordance with Annex 7, Article 5 of the Convention, the Administrative Committee may wish to elect a Chairman and a Vice-Chairman for its session.

3. ATTENDANCE OF OBSERVERS

In accordance with Annex 7, Article 2, paragraph 1 of the Convention, the Administrative Committee may decide whether competent administrations of States which are not Contracting Parties or representatives of international organizations which are not

Contracting Parties, are invited to attend the session of the Administrative Committee as observers. In accordance with Annex 7, Article 2, paragraph 2 of the Convention, international organizations referred to above, which are competent for the subject dealt with in the Annexes of the Convention, shall have the right to participate as observers in the work of the Administrative Committee.

4. STATUS OF THE CONVENTION

Consideration of a new Annex 8 on the facilitation of border crossing procedures for international road transport

The Administrative Committee may wish to recall its consideration on this subject at its fourth session in October 2000 (TRANS/WP.30/AC.3/8). It may also wish to recall the detailed considerations made by the UNECE Working Party on Customs Questions affecting Transport (WP.30) at its sessions following the third session of the Administrative Committee in October 2000 (TRANS/WP.30/204, paras. 16-18; TRANS/WP.30/202, paras. 14-19; TRANS/WP.30/200, paras. 12-17; TRANS/WP.30/198, paras. 20-24; TRANS/WP.30/196, paras. 14-17; TRANS/WP.30/194, paras. 18-23; TRANS/WP.30/192, paras. 10-13).

The Administrative Committee may also wish to recall that the objective of the new Annex 8 is to insert into the Convention complementing provisions to those already provided in Annex 1 and to define, as a first step, the measures that need to be implemented in order to

facilitate border crossing procedures for international road transport. Other border control provisions applying specifically to rail, inland water and possibly maritime and air transport might be included at a later stage. The UNECE Working Party (WP.30) had stressed in this context that the new Annex 8 should address in a comprehensive and consistent manner all major elements important for efficient border crossing procedures in international road transport of goods, covering different types of cargoes, particularly perishable foodstuffs, road vehicles, drivers as well as border crossing procedures and infrastructures.

Considering this subject, the Administrative Committee may also wish to be informed about the latest activities of the Regional Road Transport Committee (RRTC) established in the framework of the Southeast European Cooperative Initiative (SECI) that had initially prepared the International Vehicle Weight Certificate for lorries that is also part of the new Annex 8 to the Convention.

The Administrative Committee may wish to consider and adopt the proposal for a new Annex to the Convention as contained in document TRANS/WP.30/AC.3/2003/1. This document, prepared by the secretariat at the request of the UNECE Working Party WP.30, is largely based on document TRANS/WP.30/2001/16 that has already been considered by the Working Party at earlier sessions. Document TRANS/WP.30/AC.3/2003/1 takes account of these considerations and contains a number of new proposals for provisions for which in the past no consensus could be found in the Working Party. These proposals will be considered in detail by the UNECE Working Party WP.30 at its forthcoming session (4-7 February 2003) that will be held in conjunction with the present session of the Administrative Committee.

6. PROPOSALS OTHER THAN AMENDMENTS TO THE CONVENTION

(a) <u>Facilitation of border crossing procedures in international road transport</u>

The Administrative Committee may wish to be informed about progress made in the implementation of the Memorandum of Understanding (MoU) that had been prepared and signed by eleven Ministers of Transport of the States participating in the Southeast European Cooperative Initiative (SECI): Albania; Bosnia and Herzegovina; Bulgaria; Croatia; Greece; Hungary; Republic of Moldova; Romania; Slovenia; The former Yugoslav Republic of Macedonia; Turkey.

This MoU on the facilitation of international road transport of goods stipulated <u>inter alia</u> that all Parties to the MoU should accede to the "Harmonization" Convention. It also established the SECI Regional Road Transport Committee (RRTC), composed of representatives of the Parties to the MoU. The RRTC has prepared the concept and technical specifications of the International Vehicle Weight Certificate, part of the newly proposed Annex 8 to the Convention.

The next session of the RRTC hosted by Turkey will be held at Istanbul on 12 and 13 February 2003.

(b) Measures to facilitate the world-wide implementation of the Convention

The Administrative Committee may wish to continue its consideration on possible measures to facilitate the world-wide implementation of the Convention in line with resolution No. 230 adopted by the UNECE Inland Transport Committee on 4 February 1983 entitled "Technical assistance measures for the implementation of the International Convention on the Harmonization of Frontier Controls of Goods" (TRANS/WP.30/AC.3/8, paras. 25-26; TRANS/WP.30/AC.3/6, paras. 22-25; TRANS/WP.30/AC.3/4, paras. 15-20).

7. OTHER BUSINESS

(a) <u>Date of next session</u>

In accordance with Annex 7, Article 4, sub-paragraphs (ii) and (iii) of the Convention, the Administrative Committee may wish to decide on the date for its next session.

(b) Restriction on the distribution of documents

The Administrative Committee may wish to decide whether there should be any restriction with respect to the distribution of documents issued in connection with its current session.

8. ADOPTION OF THE REPORT

In accordance with Annex 7, Article 8 of the Convention, the Administrative Committee will adopt the report of its fifth session on the basis of a draft prepared by the UNECE secretariat.
