EXPLANATORY NOTES

In accordance with Annex 7, Article 4 of the Convention and in line with the decision taken at the one-hundred-and-eighth session of the UNECE Working Party on Customs Questions affecting Transport (WP.30) (TRANS/WP.30/216), the Executive Secretary of the UNECE is convening this seventh session of the Administrative Committee in conjunction with the one-hundred-and-tenth session of the UNECE Working Party (WP.30).

The UNECE Working Party (WP.30) will hold its one hundred-and-tenth session from 14 to 17 June 2005, starting at 15.00 hours on Tuesday, 14 June 2005 at the Palais des Nations in Geneva. Representatives of all Contracting Parties to the Convention are strongly recommended to participate also in this session of the Working Party. The agenda as well as other relevant documents for the session of the Working Party may be obtained directly from the UNECE secretariat or downloaded from the relevant UNECE Transport Division web site (see page 1).

QUORUM

In accordance with Annex 7, Article 6 of the Convention, "a quorum consisting of not less than one third of the States which are Contracting Parties is required for the purposes of taking decisions." As of 1 December 2002, the number of States, Contracting Parties to the Convention is 41.

1. ADOPTION OF THE AGENDA

Contracting Parties to the Convention have been invited by the Executive Secretary of the UNECE to submit proposals for amendments of the Convention. Such proposals will be circulated when received before the session.

Consideration of a new Annex 8 on the facilitation of border crossing procedures for international road transport

The Administrative Committee may wish to recall its consideration on this subject at its fourth session in October 2000 (TRANS/WP.30/AC.3/8). It may also wish to recall the detailed considerations made by the UNECE Working Party on Customs Questions affecting Transport (WP.30) (TRANS/WP.30/216, paras. 14-17; TRANS/WP.30/204, paras. 16-18; TRANS/WP.30/202, paras. 14-19; TRANS/WP.30/200, paras. 12-17; TRANS/WP.30/198, paras. 20-24; TRANS/WP.30/196, paras. 14-17; TRANS/WP.30/194, paras. 18-23; TRANS/WP.30/192, paras. 10-13). The Working Party may also wish to take note of the Ad hoc Expert Group on the new annex 8 which took place in 2003 (TRANS/WP.30/2004/12).

The Administrative Committee may also wish to recall that the objective of the new Annex 8 is to insert into the Convention complementing provisions to those already provided in Annex 1 of the Convention and to define, as a first step, the measures that need to be implemented in order to facilitate border crossing procedures for international road transport. Other border control provisions applying specifically to rail, inland water and possibly maritime and air transport might be included at a later stage. The UNECE Working Party (WP.30) had stressed in this context that the new Annex 8 should address in a comprehensive and consistent manner all major elements important for efficient border crossing procedures in international road transport of goods, covering different types of cargoes, particularly perishable foodstuffs, road vehicles, drivers as well as border crossing procedures and infrastructures.

The Administrative Committee may wish to consider and adopt the proposal for a new Annex to the Convention as contained in document TRANS/WP.30/AC.3/2005/1. This document, prepared by the secretariat at the request of the UNECE Working Party WP.30, is largely based on document TRANS/WP.30/AC.3/2003/1, which had been prepared for the fifth session of the Administrative Committee and considered at the ad hoc expert group meeting on the Convention which took place on 24 September 2003 (TRANS/WP.30/2004/12). Document TRANS/WP.30/AC.3/2005/1 takes account of these considerations as well as the conclusions of the Working Party at its one-hundred-and-eighth

session (TRANS/WP.30/216) and contains a number of revised formulations for provisions for which, in the past, no consensus could be found in the Working Party.

5. PROPOSALS OTHER THAN AMENDMENTS TO THE CONVENTION

(a) **Draft annex for facilitation of rail transport**

The Administrative Committee may wish to take note of developments in the field of facilitation of border crossing in international rail transport, in particular the considerations by the Organization for the Collaboration of Railways (OSZhD) to elaborate a new Annex to the "Harmonization Convention", which would cover issues relating to railway border crossing (TRANS/SC.2/2004/7). The Working Party on Customs Questions affecting Transport (WP.30), at its one-hundred-and-ninth session, took note that a second preparatory meeting on this issue had been held in Ukraine in November 2004, where it was decided to establish a small working group which would try to prepare the first draft for a new Annex to the "Harmonization Convention" on facilitation of border crossing for railways. The group is composed of experts (Customs, police, railways, etc.) from a few countries and it met in February 2005. The group prepared a draft Annex, to be considered by the third preparatory meeting in March 2005 and then submitted to this Working Party and the Working Party on Rail Transport (SC.2) for consideration, with the ultimate aim of presenting the final text of the Convention at an international conference in 2006. The Committee may wish to consider document TRANS/WP.30/2005/22, prepared by the OSZhD, providing a first draft for a new Annex to the "Harmonization Convention" on facilitation of border crossing for railways.

(b) Preparation of an annex for security related controls at borders

The Committee may wish to take note that the WP.30, at its previous session, has considered the issue of preparing an annex for security related issues, in particular controls at border crossings. The Working Party felt that, on the one hand, it has an important task to enhance security but also considered, on the other hand, that any security related controls should be carefully balanced against facilitation requirements. The Working Party, at the time, felt that it might be premature to adopt any provisions in the framework of the Convention at the present time, while several other organizations were still in the process of developing initiatives in this field. At the same time, it was also mentioned that all efforts should be taken

to avoid duplication of work in this field. Therefore, the Working Party requested the secretariat to work closely with the World Customs Organization (WCO) and requested the secretariat to prepare a document for one of its future sessions, containing a comparative analysis of the measures taken in the field of security controls at borders and, on that basis, to prepare a first new draft Annex to the "Harmonization Convention" concerning controls at borders linked to security.

Bearing in mind the subsequent development, in particular the elaboration of a framework for supply chain security by the WCO, the Committee may wish to consider the issue in detail.

(c) Facilitation of border crossing procedures in international road transport

The Administrative Committee may wish to be informed about progress made in the implementation of the Memorandum of Understanding (MoU) that had been prepared and signed by eleven Ministers of Transport of the States participating in the Southeast European Cooperative Initiative (SECI): Albania; Bosnia and Herzegovina; Bulgaria; Croatia; Greece; Hungary; Republic of Moldova; Romania; Slovenia; The former Yugoslav Republic of Macedonia; Turkey.

This MoU on the facilitation of international road transport of goods stipulated <u>interalia</u> that all Parties to the MoU should accede to the "Harmonization Convention". It also established the SECI Regional Road Transport Committee (RRTC), composed of representatives of the Parties to the MoU. The RRTC has prepared the concept and technical specifications of the International Vehicle Weight Certificate, part of the newly proposed Annex 8 to the Convention.

(d) Measures to facilitate the world-wide implementation of the Convention

The Administrative Committee may wish to continue its consideration on possible measures to facilitate the world-wide implementation of the Convention in line with resolution No. 230 adopted by the UNECE Inland Transport Committee on 4 February 1983 entitled "Technical assistance measures for the implementation of the International Convention on the Harmonization of Frontier Controls of Goods" (TRANS/WP.30/AC.3/8, paras. 25-26; TRANS/WP.30/AC.3/6, paras. 22-25; TRANS/WP.30/AC.3/4, paras. 15-20).

6. OTHER BUSINESS

(a) <u>Date of next session</u>

In accordance with Annex 7, Article 4, sub-paragraphs (ii) and (iii) of the Convention, the Administrative Committee may wish to decide on the date for its next session.

(b) Restriction on the distribution of documents

The Administrative Committee may wish to decide whether there should be any restriction with respect to the distribution of documents issued in connection with its current session.

7. ADOPTION OF THE REPORT

In accordance with Annex 7, Article 8 of the Convention, the Administrative Committee will adopt the report of its seventh session on the basis of a draft prepared by the UNECE secretariat.
