

- Facilitation of transport
- Guarantee for Customs
- TIR Carnet
  - Proof of existence of the guarantee
  - Information exchange

- eTIR international system



# Registration of the guarantee by the guarantor

Operator

Guarantor

## Guarantee management

- Registration of the guarantee by the guarantor
  - Operator requests a guarantee
  - Guarantor issues a guarantee
  - Guarantor registers the Guarantee centrally





## Guarantee management

- Verification of the guarantee validity by Customs
  - Operator presents the guarantee together with the declaration
  - Customs check in the Central system that the Guarantee is valid.











# Exchange of information

- Data handling at the beginning of the TIR Transport
  - Submission of the declaration
  - Acceptance of the declaration
    - Incl. Validation of the guarantee
  - Central recording of the declaration
  - Central recording of additional data (e.g. seals,...)
  - The information will be linked to the Guarantee data





# Exchange of information

## Data handling related to TIR operations

- The operator presents the Goods to Customs
- Customs will store centrally information on the:
  - Start of TIR operations
  - Termination of TIR operations
  - Discharge of TIR operations
- The information will be linked to the Guarantee data
