Corrections to the annex to Depositary Notification C.N. 1078,2000.TREATIES-3 and to document ECE/TRANS/140 (Vol. I and II), as approved by the Working Party

#### PART 1

- 1.1.3.6.2 In the list of provisions for Part 8, delete "and (3)" in the line "S2(1) and (3)".
- 1.1.3.6.3 Do not apply to the English version.
- 1.2.1 Do not apply to the English version.
- 1.4.2.2.1 (d) Delete "fixed tanks,".
- 1.6.4.5 Do not apply to the English version.

# PART 2

- 2.1.3.8 In the second sentence, replace " $LC_{50}$  (see definition in 2.3.4.7)" with " $LC_{50}^2$  (see definitions in 2.3.5.1, 2.3.5.2 and 2.3.5.3)" and add a footnote to read as follows:
  - "2 Lowest value of 96-hour LC<sub>50</sub>, 48-hour EC<sub>50</sub> or 72-hour IC<sub>50</sub> as appropriate."
- 2.2.1.1.4 In the second sentence, replace "in section 2.3.1" with "in 2.3.0 and 2.3.1".
- 2.2.1.3 Under classification code 1.4C, insert "0501 PROPELLANT, SOLID" after the existing entry for UN No. 0479, in the right column.
- 2.2.2.3 In the table, for Classification code 2F, UN No 1965, add "A" after "for mixtures" in Note 1.
- 2.2.3.1.1 Under NOTE 1, for "under the sustained combustibility test conditions given in sub-section 32.5.2 of Part III of the Manual of Tests and Criteria do not sustain combustion" read "do not sustain combustion according to the criteria of sub-section 32.2.5 of Part III of the Manual of Tests and Criteria,".

Under NOTE 6, insert the words ", highly corrosive and having a boiling point or an initial boiling point exceeding 35 °C" after "UN No. 2920 CORROSIVE LIQUID, FLAMMABLE, N.O.S.".

- 2.2.3.1.7 Replace "section 2.3.2" with "2.3.3.1 and 2.3.4".
- 2.2.41.1.17 In the table, for "Tanks", replace "over" with "below" under the heading "SADT a"
- 2.2.41.2.3 Delete the 5<sup>th</sup> indent.
- 2.2.41.4 The correction concerning the N,N'-DINITROPENTAMETHYLENETRAMINE does not apply to the English version.

In the list of remarks after the table, in remark (8) replace "2.2.41.1.16" with "2.2.41.1.15".

UN No. 1445 barium chlorate, UN No. 1446 barium nitrate, UN No. 1447 barium perchlorate, UN No. 1448 barium permanganate, UN No. 1449 barium peroxide, UN No. 2719 barium bromate and UN No. 2741 barium hypoclorite with more than 22% available chlorine are substances of Class 5.1. UN No. 1565 barium cyanide and UN No. 1884 barium oxide are substances of Class 6.1."
