Text of the Regulation,

Paragraph 4.3., amend to read:

"4.3. Notice of approval or of extension or refusal or withdrawal of approval or production definitely discontinued of a vehicle type pursuant to this Regulation shall be communicated to the Parties to the 1958 Agreement which apply this Regulation, by means of a form conforming to the model in annex 3 to this Regulation. This form shall contain in its heading:"

Insert new paragraphs 4.3.1. and 4.3.2., to read:

- "4.3.1. a circle surrounding the letter "E" followed by the distinguishing number of the country which has granted the approval; <u>2</u>/
- 4.3.2. the approval number, as prescribed in paragraph 4.2. above."

<u>Paragraphs 4.4. to 4.8.</u>, should be deleted (however, preserving footnote  $\underline{2}$ /).

Footnote 2/, amend to read:

Subsequent numbers shall be assigned to other countries in the chronological order in which they ratify or accede to the Agreement concerning the Adoption of Uniform Technical Prescriptions for Wheeled Vehicles, Equipment and Parts which can be Fitted and/or be Used on Wheeled Vehicles and the Conditions for Reciprocal Recognition of Approvals Granted on the basis of these Prescriptions and the numbers thus assigned shall be communicated by the Secretary-General of the United Nations to the Contracting Parties to the Agreement."
