A. PROPOSAL

Insert a new paragraph 2.2.3., to read:

"2.2.3. the scheme of the fuel tank mounting on a road vehicle;"

Paragraph 2.2.3. (former), renumber as paragraph 2.2.4. and amend to read:

"2.2.4. in the case of a request on the basis of Part II of the present Regulation a diagram of the entire fuel feed systems...."

Paragraph 2.2.4. (former), renumber as paragraph 2.2.5.

Paragraph 5.10., amend to read:

"5.10. Tanks must be mounted in such a way that they are protected from head on and lateral collision or impact from behind (for categories M1 and N1); there must be no prominent parts, sharp edges, etc. close up to the tank."

Paragraph 8., amend to read:

" LIQUID FUEL TANK IN THE CASE OF A REQUEST ON THE BASIS OF PART II OF THE PRESENT REGULATION"

Paragraph 9., amend to read:

"9. TESTS ON THE VEHICLE IN THE CASE OF A REQUEST ON THE BASIS OF PART II OF THE PRESENT REGULATION"

B. JUSTIFICATION

Re. para. 5.10.:

The current wording is a variant of paragraph 7.9. of Regulation No. 73, which applies to N2, N3, O3 and O4 vehicles. Therefore it is necessary to amend the paragraph as mentioned.

Re. paras. 8. and 9.:

To specify more clearly that tests are held in the case of a request on the basis of Part II of the Regulation.

Re. annexes 1B and 1B:

To distinguish which Part of the Regulation is applied.
