"3.1.8. the inscriptions "LS-1", "LS-2", "LS-3" or "LS-4" in the case of ..."

Paragraph 3.1.11., should be deleted.

Paragraph 3.1.12. (former), renumber as paragraph 3.1.11.

<u>Table 1, Note 1</u>, amend to read:

"...to the Tyre sidewalls: "F-1" or "F-2".

<u>Table 2 (2 of 3) Drive wheel tyres for agricultural tractors – Normal Section Sizes, for tyre size designation 14.9-20,</u> replace the value "1265" corresponding to the Overall Diameter (D) column, by "1165".

Annex 7, part B, text, delete the words " or F-3".

Annex 10, the table, insert two new rows to read:



EXAMPLE OF THE PICTOGRAM TO BE MARKED ON BOTH TYRE SIDEWALLS OF THE TYRES TO EXPLICIT THE MAXIMUM INFLATION PRESSURE NOT TO BE EXCEEDED FOR BEAD SEATING DURING TYRE MOUNTING



a = 2 mm min (height of lettering)

 $b=~12~mm~min~for~tyre~section~height \leq 120~mm$

18 mm min for tyre section height \geq 120 mm

c = 14 mm min (width of lettering)

The pictogram must be placed on both sidewalls.

The value of inflation pressure (2.5 bar in the example) must be the same as specified in paragraph 4.1.14. of this Regulation".
