The title of the Regulation, amend to read:

"UNIFORM PROVISIONS CONCERNING THE APPROVAL OF FRONT AND REAR POSITION (SIDE) LAMPS, STOP-LAMPS AND END-OUTLINE MARKER LAMPS FOR POWER-DRIVEN VEHICLES AND THEIR TRAILERS"

<u>Insert a new paragraph 0.</u>, to read (including the insertion of a reference to a new footnote $\underline{1}$ / and a new footnote $\underline{1}$ /):

"0. SCOPE

This Regulation applies to:

- 0.1. front and rear position (side) lamps and stop lamps for vehicles of categories L, M, N, O and T 1/; and,
- 0.2. end-outline marker lamps for vehicles of categories M, N, O and T.

<u>Paragraph 4.2.1.1.</u>, the reference to footnote $\underline{1}$ / and footnote $\underline{1}$ /, renumber as footnote $\underline{2}$ / and amend to read:

"2/ 1 for Germany, 48 for New Zealand, 49 for Cyprus, 50 for Malta, 51 for the Republic of Korea, [52 for Malaysia and 53 for Thailand]. Subsequent numbers shall be assigned "

Paragraph 6.1. (the table), the reference to footnote 1/ and footnote 1/, renumber as footnote 3/.

Paragraph 6.1. (the table), the reference to footnote 2/ and footnote 2/, renumber as footnote 4/.

Paragraph 7.2., the reference to footnote 2/ and footnote 2/, renumber as footnote 5/.
