<u>Paragraph 1.</u>, amend to read (including the insertion of a reference to a new footnote $\underline{1}$ / and a new footnote $\underline{1}$ /):

"1. SCOPE

This Regulation applies to vehicles of categories M, N, and to their trailers (category O) $\underline{1}$ / with regard to the installation of lighting and light-signalling devices.

1/ As defined in Annex 7 to the Consolidated Resolution on the Construction of Vehicles (R.E.3), (document TRANS/WP.29/78/Rev.1/Amend.2 as last amended by Amend.4)."

"4/ 1 for Germany, 50 for Malta, 51 for the Republic of Korea, [52 for Malaysia and 53 for Thailand]. Subsequent numbers shall be assigned "

<u>Paragraph 5.15.</u>, the references to footnotes $\underline{4}$ / and $\underline{5}$ / and footnotes $\underline{4}$ / and $\underline{5}$ /, renumber as footnotes 5/ and 6/.

<u>Paragraph 6.2.4.2.</u>, the reference to footnote $\underline{6}$ / and footnote $\underline{6}$ /, renumber as footnote $\underline{7}$ / and amend to read:

"7/ As defined in Annex 7 to the Consolidated Resolution on the Construction of Vehicles (R.E.3), (document TRANS/WP.29/78/Rev.1/Amend.2 as last amended by Amend.4)."
