Proposal¹

1. <u>Amendments to Annex 1</u>

In the headings of the tables for the allocation of label elements in page 259 of the English version, replace "AQUATIC TOXICITY (ACUTE)" and "AQUATIC TOXICITY (CHRONIC)" with "AQUATIC HAZARD (ACUTE)" and "AQUATIC HAZARD (LONG-TERM)".

2. <u>Amendments to Annex 2</u>

- A2.28 (b) In the title, replace "Chronic hazards" with "Long-term hazards";
 - For Category 1, replace paragraph 1 with the following text:
 - "1. For substances rapidly degradable:
 - (a) NOEC ≤ 0.01 mg/l; or if absent
 - (b) $L(E)C_{50} \le 1 \text{ mg/l and } BCF \ge 500 \text{ (or if absent log Kow } \ge 4)$
 - 2. For substances non-rapidly degradable:
 - (a) NOEC ≤ 0.1 mg/l; or if absent
 - (b) $L(E)C_{50} \le 1 \text{ mg/l}$ "

Renumber current paragraphs "2", "3" and "4" as "3", "4" and "5" respectively.

- For Category 2, replace paragraph 1 with the following text:
 - "1. For substances rapidly degradable:
 - (a) $0.01 < \text{NOEC} \le 0.1 \text{ mg/l or if absent}$
 - (b) 1 mg/l < L(E)C_{50} \le 10 mg/l and BCF ≥ 500 (or if absent log $K_{ow} \ge 4)$
 - 2. For substances non-rapidly degradable:
 - (a) $0.1 < \text{NOEC} \le 1 \text{ mg/l or if absent}$
 - (b) $1 \text{ mg/l} \le L(E)C_{50} \le 10 \text{ mg/l}^{"}$

Renumber current paragraphs "2", "3" and "4" as "3", "4" and "5" respectively.

- For Category 3, replace paragraph 1 with the following text:
 - "1. For substances rapidly degradable:
 - (a) $0.1 < \text{NOEC} \le 1 \text{ mg/l or if absent}$
 - (b) 10 mg/l < L(E)C_{50} \le 100 mg/l and BCF ≥ 500 (or if absent log $K_{ow} \ge 4)$
 - 2. For substances non-rapidly degradable:

 $10 \text{ mg/l} < L(E)C_{50} \le 100 \text{ mg/l}$ "

Renumber current paragraphs "2", "3" and "4" as "3", "4" and "5" respectively.

3. <u>Amendments to Annex 3</u>

-

- Section 1, in column (3) of Table A3.1.3 (page 301 of the English version):

replace "acute toxicity (Chapter 4.1)" with "acute hazard (Chapter 4.1)" and "chronic toxicity (Chapter 4.1)" with "long-term hazard (Chapter 4.1)";

- Section 2, in column (3) of:
 - Table A3.2.2, for P273 (page 310 of the English version);
 - Table A3.2.3, for P391 (page 319 of the English version); and
 - Table A3.2.5, for P501 (page 328 of the English version):

replace "acute toxicity (Chapter 4.1)" with "acute hazard (Chapter 4.1)" and "chronic toxicity (Chapter 4.1)" with "long-term hazard (Chapter 4.1)".

Section 3, in the matrix of precautionary statements for hazardous to the aquatic environment (pages 393 and 394 of the English version):

in the title, replace: "CHRONIC HAZARD" with "LONG-TERM HAZARD"
