GRPE agreed to resume consideration of the updated proposal by the United Kingdom to amend in Regulation No. 83 the current particle mass measurement procedure and to incorporate the particle number measurement procedure in line with the conclusions of the PMP particle measurement programme.

(b) <u>Gas-fuelled Vehicles</u> (GFV)

GRPE may wish to be informed about the set up of the new GFV group. The Chairperson of the informal group will summarize the results of the first meeting prior to the GRPE session proper.

7. HYDROGEN AND FUEL CELL VEHICLES – SUB-GROUP ENVIRONMENT (HFCV-SGE)
