#### **Item 3. UNECE Conference in Piraeus**

3. The secretariat will inform the Group about the informal session of the Conference Steering Committee in Geneva on 24 June 2008 that finalized the structure of the UNECE Conference on Hinterland Connections of Seaports, hosted by the Government of Greece in Piraeus on 17-18 September 2008. The final Conference programme is available in the informal document WP.5/GE.1 No. 1 (2008). The Group may wish to take note of the main conclusions of the Conference that will be presented by the secretariat.

A representative of Statistics Netherlands will present a Netherlands pilot project on statistical analysis of transport supply chains (Informal document GE.1 No. 2). The objective of the discussion will be to progress towards the development of conclusions and recommendations in the Group's final report.
