1998 AGREEMENT (GLOBAL)

Status reports and Notifications received by the secretariat

According to the provisions of article 7.2. of the Agreement the Contracting Parties to the 1998 Agreement shall provide the secretariat with an annual status report on the incorporation into their national or regional law of the established gtrs of which they had voted in favour. WP.29 noted that this obligation was a sufficient monitoring mechanism and invited the Contracting Parties to submit on time the above-mentioned status reports. This obligation of all Contracting Parties allows the furtherance and dissemination of information of the Agreement.
