#### II. ANNOTATIONS TO THE PROVISIONAL AGENDA

#### 1. ADOPTION OF THE AGENDA

In accordance with Chapter III, Rule 7 of the Rules of Procedure (TRANS/WP.29/690 and Amend 1) of the World Forum for Harmonization of Vehicle Regulations (WP.29), the first item on the provisional agenda is the adoption of the agenda.

### 2. REGULATION No. 66 (Strength of superstructure)

GRSG may wish to consider a proposal by the expert from Hungary based on the issues raised by GRSG-96-10, if available.

### 3. REGULATION No. 107 (M<sub>2</sub> and M<sub>3</sub> vehicles)

#### (a) Proposals for further amendments

GRSG may wish to consider a revised proposal by the expert from Belgium on over-deck vehicles, if available. GRSG agreed to resume the consideration of a proposal by the expert from Spain deleting the references in Regulation No. 107 to Regulation No. 66. GRSG may wish to consider a proposal by the expert from the United Kingdom on passengers with reduced mobility. GRSG may also wish to consider a proposal by the expert from France correcting the French version of the Regulation. Further proposals could also be considered, if available.

#### (b) Requirements for service doors, windows and emergency exits

GRSG may wish to be informed about the work progress of the informal group on Service Doors, Windows and Emergency Exits in buses and coaches (SDWEE). Furthermore, GRSG agreed to consider a revised proposal on escape hatches of trolley buses by the expert from the International Association of the Body and Trailer Building Industry (CLCCR). GRSG also agreed to continue the consideration of a proposal by the expert from France on escape hatches in vehicles of Class B.

# 4. PROPOSAL FOR A NEW DRAFT REGULATION ON FRONTAL COLLISION OF BUSES

GRSG agreed to have a final review of this proposal.

#### 5. REGULATION No. 118 (Burning behaviour of materials)

GRSG agreed to resume the consideration of the proposal prepared by the experts from France and Germany, Norway and Sweden.

#### 6. REGULATION No. 34 (Fire risks)

GRSG may wish to consider a proposal by the expert from the International Organization of Vehicle Manufacturers (OICA) on diesel vehicles. GRSG may wish to consider a proposal by the expert from the Netherlands concerning the prevention of fire risks caused by leakage of fuel, if available.

### 7. REGULATION No. 43 (Safety glazing)

GRSG may wish to resume consideration of the subject. In particular, GRSG might consider a proposal from the expert from CLEPA transposing gtr No. 6 into Regulation No. 43. GRSG might also consider a revised proposal by the expert from Germany on plastic glazing materials, if available.

#### 8. REGULATION No. 46 (Devices for indirect vision)

At the request of the expert from the European Commission (EC), GRSG agreed to resume consideration of ECE/TRANS/WP.29/GRSG/2008/26 at its 97th session. GRSG agreed to have a final review of ECE/TRANS/WP.29/2009/99 on the scope of the Regulation, before its consideration by the World forum. GRSG may wish to consider the proposal by the expert from the United Kingdom on blind spots on the passenger sides of  $N_2$  and  $N_3$  vehicles. GRSG may wish to be informed about the work progress of the informal group on Camera Monitor Systems (CMS).

#### 9. REGULATION No. 73 (Lateral protection devices)

GRSG agreed to resume consideration of this subject based on a proposal by the expert from CLCCR.

### 10. REGULATION No. 97 (Vehicle alarm systems (VAS))

GRSG agreed to have a final review of the proposal by the expert from Japan, if available.

#### 11. REGULATION No. 116 (Protection of motor vehicles against unauthorized use)

GRSG agreed to have a final review of the proposal by the expert from Japan.

#### 12. REGULATION No. 122 (Heating systems of vehicles)

GRSG may wish to consider a proposal on electric heating systems by the expert from OICA.

#### 13. REGULATION No. 125 (Forward field of vision of drivers)

GRSG may wish to consider a proposal by the expert from France on the obstruction created by the steering-wheel. GRSG may also wish to consider a proposal by the expert from Japan aiming to improve the perception of motorcycles by car drivers, if available.

#### 14. GLOBAL TECHNICAL REGULATIONS UNDER THE 1998 AGREEMENT

GRSG agreed to consider the first draft of the proposal for a gtr on motorcycle controls, tell-tales and indicators, by the expert from Italy in cooperation with the International Motorcycle Manufacturer Association (IMMA), if available.

# 15. GENERAL QUESTIONS RELATED TO THE SCOPE OF REGULATIONS ANNEXED TO THE 1958 AGREEMENT

GRSG agreed to continue consideration of this question on the basis of a proposal by the secretariat.

#### 16. DEFINITION OF NON-ROAD MOBILE MACHINERY

GRSG agreed to resume consideration of this subject.

#### 17. ALCOHOL IGNITION INTERLOCKS

GRSG might consider the draft terms of references and rules of procedure of an informal group on this subject prepared by the expert from Sweden, if available.

#### 18. REVISIONS AND EXTENSIONS OF APPROVALS

GRSG agreed to continue the consideration of this subject on the basis of a concrete proposal by the expert from OICA, if available.

# 19. PROPOSAL FOR DRAFT AMENDMENT TO THE CONSOLIDATED RESOLUTION ON THE CONSTRUCTION OF VEHICLES (R.E.3)

GRSG agreed to consider a revised proposal by the expert from the Russian Federation, if available.

#### 20. ELECTION OF OFFICERS

In compliance with Rule 37 of the Rules of Procedure (TRANS/WP.29/690), GRSG will elect the Chairperson and the vice-Chairperson for the sessions scheduled for the year 2010.

## 21. OTHER BUSINESS

GRSG might wish to consider any other subject, if necessary.
