Item 1. Introduction

1. At its sixty-third session (Geneva, 18-20 November 2009), the UNECE Working Party on Rail Transport (SC.2) expressed its full support for all initiatives that aim to unify railway law in the pan-European region and decided to set up an informal group of experts that would prepare a position paper on this issue for its sixty-fourth session in November 2010. The group would also be tasked to prepare a workshop on Euro-Asian rail transport that should take place during the sixty-fourth session of the SC.2. The Working Party asked the secretariat to invite representatives of UNECE member states, OTIF, OSJD, European Community and railway organizations to participate in the work of the informal group. The secretariat will inform participants about the responses received from the invitees.

Delegates are requested to bring copies of all relevant documents to the session. There will be no documentation available in the conference room. Before the session, documents may be downloaded from the website of the Working Party on Rail Transport (http://unece.org/trans/main/sc2/sc2.html).

 - > costs, benefits and experience with bilateral and multilateral approaches to administrative, legal and technical harmonization of diverse rail systems;
 - best practice in cooperation between the railway sector and government agencies;
 - ➤ key factors for effective international cooperation: infrastructure (border stations, rolling stock, terminals, etc), procedures (border crossing, transit, security) and contractual obligations (civil liability, consignment notes);
 - > main elements of a unified railway law and a strategy to develop such system;
 - ➤ development and administration of harmonized legal instruments for Euro-Asian rail transport.

Item 5. Programme of work

5. The Chair will outline how the conclusions reached during the preceding discussion should be reflected in the expert group activities and outputs. Subsequently, participants are expected to discuss and approve a programme of work of the group, including scheduled objectives, actions and results.

Item 6. Workshop on Euro-Asian rail transport

6. The group will discuss the topics, speakers and expected outcomes of the Workshop on Euro-Asian rail transport that is scheduled to take place during the sixty-fourth session of the SC.2 that is to be hosted by the Austrian government and OSCE in Vienna on 18-19 November 2010.
