EUROPEAN CODE FOR INLAND WATERWAYS

Reporting on the special national and regional requirements deviating from or complementing the provisions of the European Code for Inland Waterways

Note by the secretariat

I. INTRODUCTION

1. At its thirty-fourth session, the Working Party considered a proposal of the informal working group on European Code for Inland Waterways (CEVNI) to delete, as much as possible, footnotes to the CEVNI provisions (ECE/TRANS/SC.3/WP.3/2009/2, paragraphs 3-6). The informal group proposed to reserve the right of national and regional authorities to adopt different rules, if required by the local navigation conditions, in a separate chapter on special regional and national requirements, which would list all articles to which derogations are permitted. To provide an adequate reporting mechanism, the informal group also proposed to establish and maintain on a yearly basis a CEVNI status document containing information on the national and regional derogations to the articles listed in the new chapter 9. The Working Party approved the proposal of the informal working group (ECE/TRANS/SC.3/WP.3/68, paragraph 8 (a)) and, at its thirty-fifth session finalized the text of the new chapter 9 (ECE/TRANS/SC.3/WP.3/70, paragraph 16).

2. At its fifty-third session, the Working Party on Inland Water Transport in its Resolution No. 66 adopted a new chapter 9 on "Regional and National Special Requirements" (ECE/TRANS/SC.3/115/Rev.4). The new article 9.01 of CEVNI stipulates that:

1. The competent authorities may omit, complement or modify the provisions of Chapters 1-8 and, in particular, the provisions listed in this Chapter, when this is required by the conditions of navigation. In this case, they shall report on these differences to the Working Party on Inland Water Transport (SC.3);

2. The competent authorities shall also report to the Working Party on the additional local requirements existing in their region.

3. At its fifty-third session, the Working Party on Inland Water Transport also stressed the importance of an appropriate mechanism for dealing with the exceptions to the CEVNI rules, established by Governments and River Commissions in accordance with the new Chapter 9. The Working Party agreed that the secretariat would contact the delegations in advance of the next SC.3 session in 2010 with a special questionnaire aimed at collecting the information on the implementation process (ECE/TRANS/SC.3/183, paragraphs 12-13).

4. In accordance with the decisions of the Working Party on Inland Water Transport, the secretariat prepared an initial proposal on the format of the special questionnaire, presented below, as well as the status document on CEVNI to be prepared for the 2010 session of SC.3.

II. DRAFT QUESTIONNAIRE ON REGIONAL AND NATIONAL SPECIAL REQUIREMENTS

5. The draft questionnaire on regional and national special requirements to be filled by Governments and River Commissions includes three sections:

- (a) Information on special requirements deviating from CEVNI in accordance with Chapter 9 "Regional and National Special Requirements";
- (b) Information on other deviations from articles of Chapters 1-8 of CEVNI, if any;
- (c) Information on the additional requirements complementing Chapters 1-8 of CEVNI, if any.

6. Part I on special requirements deviating from CEVNI in accordance with chapter 9 will include the following table:

8. In Part III of the questionnaire, the administrations will be invited to list and provide a reference to the additional requirements complementing the provisions of CEVNI Chapters 1-8.

9. Based on the information received, the secretariat will prepare regular reports on the CEVNI implementation by Governments and River Commissions in the following format proposed in document ECE/TRANS/SC.3/WP.3/2009/2, Annex II:
