Background

1. At the Safety Committee meeting held from 24 to 28 August 2009, the Swiss delegation briefly presented informal document INF.7 relating to proposals for corrections and amendments. The document was subsequently first considered by an informal group at a meeting held during the session. The Safety Committee invited the representative of Switzerland to submit an official revised document for the next session.

Proposal

2. It is proposed to harmonize as far as possible the provisions of ADN with those of ADNR and to avoid divergences. In addition, the different language versions of ADN should correspond more closely. The modifications are set out below.

Justification

3. A comparison between the provisions of ADNR and those of ADN reveals certain divergences. In order to avoid problems during incorporation of such provisions, divergences should be eliminated as far as possible. The reasons for the individual proposals are set out in informal document INF.7 presented at the previous session and are not reproduced in the present document.

Corrections

- 4. The following corrections are proposed:
- 1.16.1.2.2 Amend to read as follows:

The certificate of approval shall attest that the vessel has been inspected and its construction and equipment comply with the applicable provisions of this Regulation.

7.2.4.15.1 At the end of the paragraph, delete: "9.3.2.26.3 or 9.3.3.26.3".

8.6.3 Checklist ADN

On page 1 of the checklist, in the header "Particulars of the cargo", insert: "UN number or" before "identification number".

On page 2 of the checklist, in the brackets in the first line, insert: "or have gas unloaded" after "loaded with gas".

On page 3 of the checklist, in section 6.1, replace both occurrences of "hoses" by "pipes".

9.3.1.25.7 Amend the penultimate sentence to read as follows:

"The maximum permissible overpressure or vacuum shall be indicated on each installation."

9.3.3.10.5 Concerns the German version only.

9.3.3.21.9 Concerns the German version only.

9.3.3.22.4 (a) The first part of the correction does not concern the English version.

"In the States where the reporting duty is in force, the master of a vessel for which marking in accordance with 7.1.5.0/7.2.5.0 is required shall, prior to the start of any voyage, report, in accordance with the provisions referred to in paragraph 1.1.4.6.1, to the competent authority of the State in which the voyage has started."

- 8.1.2.8 At the end, delete: "unless agreements concluded between the countries concerned in the transport operation provide otherwise".
- 8.1.6.2 In the first sentence, replace "products" by "products for the operation of the vessel and residual cargo".
- 8.1.6.3 Amend to read as follows:

"The special equipment referred to in 8.1.5.1 and the <u>flammable</u> gas detection system shall be checked and inspected in accordance with the instructions of the manufacturer concerned <u>either by the manufacturer itself or</u> by persons authorized for this purpose by the competent authority. A certificate concerning this inspection shall be carried on board."

8.1.11 Register of operations during carriage relating to the carriage of UN No. 1203

At the end of the first sentence, insert: "including at least the particulars referred to in subsection 7.2.4.12".

9.3.3.11 Hold spaces and cargo tanks

9.3.3.11.4 In the third paragraph, insert: "loading and" before "unloading". Add a new third sentence to read "These pipes shall be fitted at least 0.60m above the bottom."

9.3.x.21 Safety and control installations

9.3.x.21.7 In the second paragraph, insert "and unloading" after "loading" and "or unloading" after "the loading".
