Proposal for Supplement 2 to Regulation No. 89 (Speed limitation devices)

Submitted by the Working Party on Brakes and Running Gear*

The text reproduced below was adopted by the Working Party on Brakes and Running Gear (GRRF) at its sixty-seventh session in order to include vehicles of category M_2 in the scope of the Regulation. It is based on ECE/TRANS/WP.29/GRRF/2010/4, not amended (ECE/TRANS/WP.29/GRRF/67, para. 27). It is submitted to the World Forum for Harmonization of Vehicle Regulations (WP.29) and to the Administrative Committee (AC.1) for consideration.

^{*} In accordance with the programme of work of the Inland Transport Committee for 2006—2010 (ECE/TRANS/166/Add.1, programme activity 02.4), the World Forum will develop, harmonize and update Regulations in order to enhance the performance of vehicles. The present document is submitted in conformity with that mandate.

Paragraph 1.1.1., amend to read:

"1.1.1. Part I: Vehicles of categories 1/M₂, M₃, N₂ and N₃ 2/ equipped with an SLD and to vehicles of categories M and N equipped with an adjustable speed limitation device ASLD which have not been separately approved according to Part III of this Regulation, or to vehicles so designed and/or equipped that their component parts can be regarded as totally or partially fulfilling the function of an SLD or ASLD, as appropriate."

Paragraph 1.1.2., amend to read:

"1.1.2. Part II: The installation on vehicles of categories M₂, M₃, N₂ and N₃ of SLDs and installation on vehicles of categories M and N of ASLD which have been type approved to Part III of this Regulation."

Paragraph 1.1.3., amend to read:

"1.1.3. Part III: SLDs which are intended to be fitted to vehicles of categories M₂, M₃, N₂ and N₃ and ASLD which are intended to be fitted to vehicles of categories M and N."

Paragraph 1.2.1., amend to read:

"1.2.1. A speed limitation device (SLD) or function (SLF) shall limit the maximum speed of vehicles of categories M_2 , M_3 , N_2 and N_3 ."

Paragraph 1.2.2., amend to read:

"1.2.2. When fitted, the adjustable speed limitation device (ASLD) or function (ASLF) shall limit the speed of vehicles of categories M and N to a speed voluntarily set by the driver when it is activated."

Delete paragraph 1.2.3.

Paragraph 5.1., amend to read:

"5.1. Requirements for vehicles of categories M_2 , M_3 , N_2 and N_3 equipped with SLF"
