

## 2. Regulation No. 66 (Strength of superstructure)

The Working Party on General Safety Provisions (GRSG) agreed to consider a revised version of ECE/TRANS/WP.29/GRSG/2010/2 on double deckers with more justification by the expert from Hungary, if available.

## 3. Regulation No. 107 (M<sub>2</sub> and M<sub>3</sub> vehicles)

#### (a) Proposals for further amendments

GRSG agreed to consider a revised version of ECE/TRANS/WP.29/GRSG/2010/3 by the expert from Sweden on passengers with reduced mobility, if available. GRSG agreed to GRSG-98-18 as a reference document and to consider ECE/TRANS/WP.29/GRSG/2010/19 by the expert from Spain proposing to increase the agreed vehicles. **GRSG** spacing in Class Ш consider ECE/TRANS/WP.29/GRSG/2010/24 prepared by the secretariat and updating the cross reference to Regulation No. 66 with regard to the strength of superstructure. GRSG agreed to consider ECE/TRANS/WP.29/GRSG/2010/27 by the expert from the International Organization of Motor Vehicle Manufacturers (OICA) on the gangway gauging device. GRSG may wish to consider ECE/TRANS/WP.29/GRSG/2010/33 by the expert from the European Commission (EC) on the accessibility of prams. Further proposals may also be considered, if available.

The informal group on Service Doors, Windows and Emergency Exits in buses and coaches (SDWEE) will meet again on 18 October 2010, from 10.30 a.m. until 17.30 p.m., and on 19 October 2010, from 9.30 a.m. until 12.30 p.m., (time to be confirmed by the Chair of the informal group), in conjunction with the proper session of the Working Party on General Safety Provisions (GRSG). GRSG may wish to be informed about the work progress of the SDWEE informal group. Further proposals may also be considered, if available.

# 4. Regulation No. 118 (Burning behaviour of materials)

GRSG agreed to resume the consideration of a revision of GRSG-98-09 prepared by the experts from France, Germany, Norway and Sweden, if available.

# 5. Regulation No. 34 (Fire risks)

GRSG may wish to consider a proposal by the expert from OICA on diesel vehicles, if available.

## 6. Regulation No. 43 (Safety glazing)

GRSG agreed to consider ECE/TRANS/WP.29/GRSG/2010/10/Rev.1 from the expert from the European Association of Automotive suppliers (CLEPA) transposing gtr No. 6 into Regulation No. 43. In this respect GRSG agreed to keep as reference document informal document No. GRSG-97-08. GRSG agreed to consider ECE/TRANS/WP.29/GRSG/2010/23 by the expert from France on vehicles with the driver in the central position. GRSG may wish to consider ECE/TRANS/WP.29/GRSG/2010/26 from CLEPA correcting Supplement 12 to Regulation No. 43. GRSG may wish to decide whether an informal group on Regulation No. 43 is needed on the basis of draft terms of Reference and Rules of procedure prepared by the expert from Germany, if available.

# 7. Regulation No. 46 (Devices for indirect vision)

GRSG agreed to consider ECE/TRANS/WP.29/GRSG/2010/29 by the expert from the United Kingdom of Great Britain and Northern Ireland on blind spots on the passenger sides of  $N_2$  and  $N_3$  vehicles.

# 9. Regulation No. 121 (Identification of controls, tell-tales and indicators)

GRSG may wish to consider ECE/TRANS/WP.29/GRSG/2010/28 by the experts from the United Kingdom and OICA, introducing a symbol on electronic stability control in Regulation No. 121. Furthermore, GRSG agreed to consider ECE/TRANS/WP.29/GRSG/2010/20 by the expert from Canada proposing new symbols.

# 11. Regulation No. 125 (Forward field of vision of drivers)

GRSG agreed to continue consideration of ECE/TRANS/WP.29/GRSG/2010/4 by the expert from Japan aiming to improve the perception of motorcycles by car drivers. The expert from Japan agreed to provide additional justifications on this proposal.

# 12. Global technical regulations under the 1998 Agreement

### (a) Proposal to develop a gtr on motorcycle controls, tell-tales and indicators

GRSG may wish to be informed about the progress of the informal group on the gtr on motorcycle controls, tell-tales and indicators. A first list of symbols is expected for consideration by GRSG.

#### (b) Proposal to amend gtr No. 6 (Safety glazing)

GRSG agreed in principle with the proposal to develop an amendment to gtr No. 6 and invited the expert from the EC to prepare a formal proposal with a draft report for consideration by GRSG at its October session.

# 13. Draft Rule No. 2 (1997 Agreement)

# 14. Revisions and extensions of approvals

GRSG agreed to address this subject again on the basis of the result of discussion by WP.29 on the test case concerning Regulation No.46.

# 15. Revision of the consolidated Resolution on the Construction of Vehicles (R.E.3)

WP.29 subsidiary Working has requested its **Parties** to review ECE/TRANS/WP.29/2009/123 and its corrigenda and to send their comments for its March 2011 session (ECE/TRANS/WP.29/1079, para. 81). GRSG experts were invited to give their final comments on this proposal at the October 2010 session of GRSG. GRSG agreed to send ECE/TRANS/WP.29/GRSG/2010/14 and its Corrigendum 1 together with the comments on the revised R.E.3 to WP.29, for consideration by WP.29 at its March 2011 session. GRSG also agreed to consider a revised proposal on buses with less than eight seats by the expert from the Russian Federation, if available.
