The Council of Arab Ministers of Transport (CAMT) in its 24th ordinary session, held on 26/10/2011, has decided the following:

- Refereeing the AULT's worksheet on conditioning the acquisition of suitable scientific qualification as a requirement to work in the Land Transport Sector, to the Land Transport Technical Committee to examine it in light with the established procedures in the Arab Countries and raise recommendations on this regard to the executive office in its coming session.

The Council of Arab Ministers of Transport in its 24th ordinary session, held on 26/10/2011, decided the following:

- 1- Take note of the recommendations of the third International seminar on the international transport of dangerous goods and call on members to continue its cooperation with the International Road Union (IRU) and the AULT.
- 2- Call on Member States of the Arab League who have not yet acceded to the ADR Agreement concerning the International Carriage of Dangerous Goods by Road (ADR) to quickly join the agreement and effectively implement its items and reap the fruits of its implementations.
- 3- Call on stakeholders in the Arab Land Transport industry to provide high level vocational training on the transport of dangerous goods, based on the international established criteria.
