Request for consultative status by the World Federation of Building Service Contractors (WFBSC)

Note by the secretariat

The secretariat has received the attached application from WFBSC for consideration at the December 2011 session.



I. Aim

The aim of this application is to obtain consultative status with the Sub-Committee of Experts on the GHS.

II. Purpose of the WFBSC

The World Federation of Building Service Contractors has the following mission statement and general objectives.

III. Mission statement

"The WFBSC is dedicated to achieving universal recognition for the building service contracting industry and to improving the awareness, knowledge and professional competence of its worldwide membership and should compliment regional and national aims."

The World Federation of Building Service Contractors is a dynamic union of national and international associations as well as individual contracting companies, manufacturers and suppliers from around the globe.

The result of this union is an international forum in which contractors, manufacturers and suppliers to the industry can address and solve problems of common concern, exchange new ideas and techniques, and promote the building service contracting industry.

IV. General objectives

- Promote global recognition of the size, scope, role and value of the professional building service contractor.
- Increase the knowledge and improve the professional competence of its members by offering global educational forums.
- Increase member awareness of industry similarities and differences worldwide.
- Generate and maintain a professional and social relationship between its associate members (manufacturing companies) and other WFBSC members (contractors).
- Utilize volunteer and professional staff resources efficiently in order to achieve the aims of the WFBSC and the expectations of member contractors and associates.

V. Our interest in the GHS sub-committee

Our interest in the GHS sub-committee is as a result of the effect that the introduction of GHS rules will have on the classification and labelling of cleaning chemicals. Cleaning chemicals are used by every single cleaning business in the world. The rules that apply to those chemicals will have an impact on all the members of the WFBSC and on all the companies that are members of the national associations. We are greatly concerned that the current rules will lead to a reduction in health and safety for cleaning workers and also an increase in environmental impact. We seek consultative status with the sub-committee so as to understand more about the new regulations and also to improve the understanding of

sub-committee members of the challenges faced by the cleaning industry in implementing these new regulations.

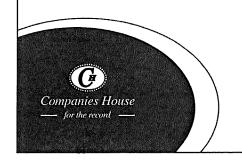

Rules of the WFBSC

RULES OF THE WORLD FEDERATION OF BUILDING SERVICE CONTRACTORS

ARTICLE I

NAME AND LOCATION

- Section 1. The name of this organization shall be the World Federation of Building Service Contractors.
- Section 2. The principal office of the Federation shall be known as the Secretariat. This office may move to any member association which is equipped to provide adequate administrative management, and, on the approval of the Board of Directors, this office may move.

ARTICLE II

MISSION STATEMENT

"The WFBSC is dedicated to achieving universal recognition for the building service contracting industry and to improving the awareness, knowledge and professional competence of its worldwide membership and should complement regional and national aims."

OBJECTIVES

- A. Promote global recognition of the size, scope, role and value of the professional building service contractor.
- B. Increase the knowledge and improve the professional competence of its members by offering global educational forums.
- C. Increase member awareness of industry similarities and differences worldwide.
- D. Generate and maintain a professional and social relationship between its Associate members and other WFBSC members (contractors).
- E. Utilize volunteer and professional staff resources efficiently in order to achieve the aims of the WFBSC and the expectations of member contractors and associates.

ARTICLE III

MEMBERSHIP

- Section 1. Categories of Membership. The categories of membership in the Federation shall be:
- A. **Full Member**. Those associations representing the building service contracting industry in their respective country. Membership is restricted to one association from each country. Admission in or expulsion from the Federation is entirely at the discretion of the WFBSC Board of Directors.
- B. **Associate Members**. Those companies engaged in the manufacturing, converting or supplying of products or services needed in the building service contracting industry. Associate members may enjoy all of the privileges and rights of membership in the Federation except the right to place a representative on the Board of Directors;

- C. **Affiliate Members**. Those associations or companies engaged in allied industries. Affiliate members may enjoy all of the privileges and rights of membership in the Federation. Each affiliate member will be entitled to nominate one representative from their particular industry group to serve on the Board of Directors; however, with no voting rights;
- D. **Subscribing Members**. Those institutions or organizations engaged in research, education and training and similar activities, building service contracting companies or individuals and others who are interested in the activities of the building service contracting industry and are not eligible for membership under any other category. A Subscribing member may enjoy all of the privileges and rights of membership except the right to place a representative on the Board of Directors;
- E. **Honorary Members**. Any person, firm, corporation, or organization not otherwise eligible for membership in the Federation who has rendered distinctive service or assistance to the Federation and whom the Board of Directors determines merits special recognition by the Federation. Nominations may be made by any member of the Board of Directors. A nominee will be elected to Honorary membership upon the affirmative vote of two-thirds of the Board of Directors.
- Section 2. Requirements of Membership. Application for membership in the Federation shall be in writing to the Secretariat. To qualify for membership in the Federation in the Member Association Category, an association must demonstrate, upon request, that it's Constitution and Rules requirements comport with generally accepted standards of conduct and practice found in the building service contracting industry.
- Section 3. Admission of Members. The Secretariat shall consult by email with the Board of Directors about all applications. Board members have 14 days from the date of consultation to express a view on the application. If no objections have been received within 14 days then the new member is accepted. Admission into the Federation automatically constitutes acceptance of the Rules of the Federation. If an objection has been expressed, then admission shall be by a majority of responses within 28 days.
- Section 4. Duration of Membership. Membership in the Federation may terminate by voluntary withdrawal as herein provided, or otherwise pursuant to these Rules. All rights, privileges and interests of a member in or to the Federation shall cease upon the termination of membership. Any member may, by giving written notice of such intention, withdraw from membership. Withdrawal from the Federation, however, does not absolve a member of its financial obligations. No association, firm, or individual withdrawing from the Federation shall be entitled thereafter to use or display any Federation insignia in any way whatsoever.
- Section 5. Suspension or Expulsion. Membership in the Federation may be suspended or terminated by the Board of Directors for cause. Sufficient cause for such suspension or termination of membership shall be the violation of the Rules or any other lawful rule or practice duly adopted by the Federation, or by any conduct prejudicial to the interests of the Federation. Suspension or termination shall be by two-thirds vote of the entire membership of the Board of Directors: PROVIDED THAT a statement of the charges shall have been mailed by registered mail to the last recorded address of the member at least 60 days before final action is taken. The statement shall be accompanied by a notice of the time and place of the meeting of the Board of Directors at which time the charges shall be considered and the member shall have the opportunity to appear in person or by his representative and present any defense to such charges before action is taken thereon.

Section 6. Reinstatement. An expelled former member may, upon application to the Board of Directors, be reinstated by a two-thirds vote of the entire Board of Directors. Such application may not be presented to the Board until at least one year has passed since such member has been expelled.

ARTICLE IV

DUES AND REVENUE

- Section 1. The annual dues for each class of membership in the Federation shall be determined by the Board of Directors. There shall be no annual dues for Honorary members.
- Section 2. The fiscal period for the Federation is January 1 to December 31. Any changes shall be determined by a unanimous vote of the Board of Directors. Annual dues shall be due and payable within the first two months of the calendar year. At least subsequent to each Congress, a duly authorized audit shall be conducted and the results presented to the Board of Directors at its next meeting.
- Section 3. The revenues of the Federation shall comprise at least the following:
 - A. Annual dues paid by all Member Associations, Associate Members, Affiliate Members and Subscribing Members
 - B. Proceeds from the publications of the Federation;
 - C. Donations from private persons, corporate bodies, associations, or public institutions;
 - D. Proceeds from the property of the Federation;
 - E. Proceeds from the World Congresses of Building Service Contractors and other activities conducted by the Federation.

The income and property of the Federation shall be applied solely towards the promotion of the objectives and purposes of the Federation and no part of said income or property shall inure or be distributed to the members of the Federation except as provided in Article XIII, Section 5. All sums received shall be deposited by the Treasurer or the Executive Vice President in the bank or banks approved by the Board of Directors.

- Section 4. Members who fail to pay their entrance fees or dues within 30 days from the time the same shall become due shall be notified by the Federation Treasurer or the Executive Vice President. If payment is not made within the next succeeding 30 days, non-payment shall be reported to the Board of Directors as in arrears, and, if so ordered by a majority vote of the Directors present and voting thereon such delinquent members shall, without further notice and without hearing, be dropped from the rolls and thereupon forfeit all rights and privileges of membership.
- Section 5. No dues shall be refunded to any Member Association whose membership terminates for any reason. No dues shall be refunded to the other membership categories whose membership terminates for any reason.

ARTICLE V

BOARD OF DIRECTORS

- Section 1. Authority. The governing body of the Federation shall be the Board of Directors. The Board of Directors shall have supervision, control, and direction of the affairs of the Federation, its committees and publications; shall determine its policies and changes therein; shall actively prosecute its objectives and purposes; shall elect the Officers of the Federation. The Board may adopt such rules and regulations for the conduct of its business as shall be deemed necessary, and may, in the execution of the power granted, delegate certain of its authority and responsibility to a sub-committee.
- Section 2. Composition. There shall be no predetermined number of Directors serving on the Board of Directors. The Board shall consist of the President, the President-elect, the four Vice Presidents, the Treasurer, the immediate Past President and one Director appointed by each Member Association, all of whom shall have voting rights. In addition, all Past Presidents, Honorary Vice Presidents, Honorary Members and one representative of each Affiliate Member industry group are eligible to attend Board meetings but shall not have any voting rights.
- Section 3. Eligibility. To be eligible to serve on the Board of Directors, and to have voting rights, one must be an officer of the Federation or an official representative of a Member Association and be duly appointed by it to serve in that capacity.
- Section 4. Terms. There shall be no fixed terms of office for Directors. However, each Member Association shall nominate its official representative on an annual basis.
- Section 5. Regular Meetings. There shall be an annual meeting of the Board of Directors at such time and at such place as the Board may prescribe. Notice of such meeting shall be given to the Directors not less than 60 days prior to the meeting date.
- Section 6. Special Meetings. Special meetings of the Board of Directors may be called by the President or shall be called by the President upon the written request of 40 percent of the duly appointed Directors at such time and at such place as he may prescribe. Notice of special meetings of the Board shall be given to the Directors not less than 60 days before the meeting is held.
- Section 7. Quorum. Half of the members of the Board of Directors who have voting rights shall constitute a quorum at any meeting of that Board, provided, however, that representatives from Member Associations in at least two continents are in attendance.
- Section 8. Voting. Any official action by the Board of Directors shall be by voice or roll call vote. All members of the Board are entitled to one vote. Except where otherwise specified in these Rules, any action must be approved by a majority of those attending the meeting. It is provided, however, that any action involving the increase of annual dues must be approved by a vote of 2/3 of the Directors present; however, that representatives from Member Associations in at least three continents are in attendance. Voting rights of a Director shall not be delegated or exercised by another unless authorized in writing signed by the Director

delegating the exercise of his vote to another. No member of the Board shall, however, be entitled to represent more than one other Director.

- Section 9. Voting by Mail or Email. Action taken by mail or email ballot vote by members of the Board of Directors, in which at least a majority of such Directors, in writing, indicate themselves in agreement, shall constitute a valid action of the Board if reported at the next regular meeting of the Board, but in no event will any mail or email vote be valid unless at least 40 percent of the Board responds in such mail or email vote. All requests for mail or email ballot shall be accompanied by sufficient explanation and documentation to ensure that Directors are fully and fairly informed concerning the propositions being voted upon by mail or email.
- Section 10. Absence. Any member of the Board unable to attend a meeting shall, in a letter addressed to the President, state the reason for his absence. If any member of the Board is absent from three (3) consecutive meetings, his/her resignation shall be deemed tendered and accepted. The association the Director represents shall be advised of this resignation and requested to nominate another representative.
- Section 11. Vacancies. Any vacancy that may occur on the Board of Directors by reason of death, resignation or otherwise shall be filled by the appointment of a Director by the Member Association which has lost its representation on the Board.
- Section 12. Removal. Any member of the Board of Directors may be removed from office for cause at any time by the affirmative vote of two-thirds of the entire Board of Directors and after notification of the national association involved.
- Section 13. Compensation. The duly appointed Directors of the Board of Directors shall not receive any compensation for their services.

ARTICLE VI

OFFICERS

- Section 1. Officers. The elected officers of the Federation shall be a President, a President-elect, four Vice Presidents, and a Treasurer and any other officers as may from time to time be designated by the Board of Directors.
- Section 2. Eligibility. To be eligible to serve as an officer of the Federation one must be the official representative of a Member Association and must have served at least one year as a member of the Board of Directors of the Federation. At no time may there be more than two officers from any one Member Association. Each candidate for office must be sponsored by one member of the Board of Directors. Current members of the Board are eligible to run for elected office.
- Section 3. Elections. Officers shall be elected at the Congress meeting of the Board of Directors. The ballot shall contain the names of all the candidates who have been sponsored by one member of the Board of Directors. A Director may sponsor only one candidate for each elected office. Members of the Board who are running for office may also cast one vote for each office. A candidate will be elected if he receives the greatest number of votes tallied for that office, be it a majority or a plurality. If a tie results between any two or more candidates for

- any elected office, there shall be a run off election between such candidates. A teller appointed by the President shall record and announce the election results.
- Section 4. Terms. All officers shall hold office until their successors are elected and assume office. All elected officers shall be eligible for re-election. Terms of office will normally be the period between World Congresses.
- Section 5. Duties. All elected officers shall serve concurrently as members of the Board of Directors and as members of the Executive Committee and are to have one vote each on both the Board and on the Executive Committee. Additionally, the officers shall individually have the following duties:
 - A. The PRESIDENT must be the CEO or equivalent of a building service contracting firm and shall be responsible for the determination of Federation policy between meetings of the Board of Directors and the Executive Committee and shall also preside as chairman of both the Board and the Executive Committee. He shall also serve as a member, ex officio, with the right to vote on all committees. He shall perform all other duties as are incidental to the office of President or as may be prescribed by the Board of Directors. The President shall report to the Board on the progress of the Federation.
 - B. The PRESIDENT-ELECT shall have automatic succession to the Presidency at the end of the President's term. He shall also preside over meetings in the absence of the President.
 - C. The four VICE PRESIDENTS shall be responsible for the orderly and business-like conduct of such duties as are individually assigned to them by the President. In the event of the temporary disability or absence of the President or the President-elect from meetings they shall act in his stead.
 - D. The TREASURER shall keep an accurate account of all monies received and expended for the use of the Federation and shall make disbursements as authorized by the Board and/or Executive Committee. He shall also report on the financial condition of the Federation to the Board of Directors every six (6) months and at any other time when called upon by the President. The Annual Report by the Treasurer under authority of the Board of Directors may be assigned in whole or in part to the paid Executive Vice President appointed by the Board to manage the Federation.
- Section 6. Honorary Officers. Any person who has rendered outstanding and distinguished service to the Federation and whom the Board of Directors determines merits special recognition by the Federation. Nominations may be made by any member of the Board of Directors. A nominee will be elected to Honorary Officer upon the affirmative vote of two-thirds of the Board of Directors. An Honorary Officer may enjoy all of the privileges and rights of membership including attendance at Board meetings but shall have no voting rights.
- Section 7. Executive Vice President. The administration and management of the Federation shall be vested in a remunerated staff head appointed by the President and approved by the Board of Directors. He/she shall have the title of Executive Vice President or such other title as the Board shall from time to time deem desirable. Said salaried head of the Federation shall

employ and may terminate the employees necessary to carry out the work of the Federation. He/she shall manage and direct the functions as may be defined by the Board. He/she shall serve as secretary for the Federation, and in such capacity he/she shall give notice and attend meetings of the Federation; keep a list of the membership, keep a record of the proceedings of the meetings of the Federation; notify members of their suspension and expulsion, acknowledge any withdrawals and notify such members of the acceptance thereof. He/she may also be authorized to sign singly on behalf of the Federation within the limits of these instructions.

- Section 8. Vacancies and Removal. Vacancies in any elective office by reason of death, resignation or otherwise, may be filled for the balance of the term thereof by the Board of Directors at any special meeting or by mail ballot. The Board, in its discretion, by two-thirds vote of all of its members, may remove any officer for cause.
- Section 9. Authority to Sign. Authority to sign singly on behalf of the Federation shall be limited to the President, the President-elect, the Treasurer and the Executive Vice President, except that the President may authorize other members of the Executive Committee to sign singly on the behalf of the Federation.
- Section 10. Compensation. Elected officials of the Federation shall not receive any compensation for their services.

ARTICLE VII

STANDING AND SPECIAL COMMITTEES

Section 1. Special Committees. The President, with the approval of the Board of Directors, shall appoint such other committees, sub-committees, or task forces as are necessary and which are not in conflict with other provisions of these Rules, and the duties of any such committees shall be prescribed by the Board of Directors upon their appointment.

ARTICLE VII

AUDITORS

At least after every Congress, an independent non-member auditor shall be appointed by the Board of Directors. The independent auditor shall inspect the accounts of the Federation and submit to the Board a written report of the audit.

ARTICLE IX

DISPUTES

Any dispute over professional or industrial problems arising between Member Associations or any dispute between individual members of different Member Associations may be submitted to the Board of Directors for an opinion. This opinion will not be legally binding upon either party to the dispute.

ARTICLE X

LIABILITY FOR DEBTS

- A. The WFBSC will budget to at worst breakeven financially in any give year and shall be managed to achieve this aim. However, in the event that unavoidable expenditure is incurred over an above the income of the WFBSC, then the following procedure shall apply.
- B. The Board of Directors alone by a vote of two-thirds of the whole Board of Directors shall have the authority to place special assignments on dues paying members to settle deficits in the payment of unforeseen costs. No assessment shall exceed, in proportion, a Member Association's average annual dues for the past five (5) years.
- C. In order to avoid such deficits, the annual dues level shall be established so as to create and maintain a reserve equal to at least one year of anticipated budget expenses by the end of 2015.
- D. No expenditures in excess of US \$5,000.00 shall be allowed except upon the authority of not less than two (2) authorized officers of the Federation or one (1) authorized officer and the Executive Vice President. Additionally, wire transfers in excess of US \$5,000.00 must be approved by the Board of Directors.

ARTICLE XI

MODIFICATION OF RULES

The amendment, modification or revocation of these Rules, in whole or in part, requires the affirmative vote of two-thirds of the entire Board of Directors either at an annual or special meeting or by mail (including email) vote.

Amendment, modification, or revocation of these Rules may be proposed by any member of the Board of Directors and must be voted upon by the Board within six months.

ARTICLE XII

DISSOLUTION AND LIQUIDATION

- Section 1. The dissolution and liquidation of the Federation may be proposed by not less than one-third of the members of the Board of Directors.
- Section 2. A resolution on the dissolution and liquidation of the Federation requires the affirmative vote of eight tenths of the members of the Board of Directors.
- Section 3. In the event of the dissolution of the Federation having been decided, a liquidation committee appointed by the Board of Directors shall be responsible for the liquidation.
- Section 4. In case of dissolution of the Federation, the current administration expenses shall be paid first, then the liquidation expenses and after those such remaining expenses as may have been agreed to by the Board.

Section 5. The Board of Directors shall dispose of any assets left over after all the liabilities of the Federation have been met. Such assets will be refunded to the dues paying members in proportion to their average annual dues over the preceding five (5) years.

ARTICLE XIII

LANGUAGE

The official language of the Federation shall be English. Publications and correspondence of the Federation shall be in the official language. However, necessary translation facilities shall be provided at Congresses for groups of fifty (50) or more persons, upon request.

ARTICLE XIV

EMBLEM

The Federation shall have an emblem of such design as the Board of Directors may adopt, and such emblem shall be available only to members of the Federation in good standing.

ARTICLE XV

GOVERNING LAW

These Rules shall in all respects be read and construed in conformity with the laws of the United Kingdom. In the event of dispute, only the English version of the Rules shall be deemed authentic.

ARTICLE XVI

WAIVER

Any article may be waived by unanimous vote of the Board of Directors at a Board meeting, provided that four-fifths of the total voting strength of the Board participates in the vote.

Any rule and any policy may be waived by a unanimous vote of the Board of Directors at a Board meeting, provided that two-thirds of the total voting strength of the Board participates in the vote.

ARTICLE XVII

PROXY VOTES

Members unable to attend the annual meetings should give a proxy vote to another Board member or notify the Executive Vice President in writing of their voting intentions.

Board members are entitled to present those proxies to a maximum of one (1).

2011 WFBSC World Congress Building a Sustainable Industry Protecting the Planet, Developing People, Maximizing Profit

(Auckland, New Zealand, 6 – 10 February 2011)

COMMUNIQUE (10 February 2011)

Preamble

- 1. We the participants of the 2011 WFBSC World Congress, held from 6 to 10 February 2011 in Auckland, New Zealand, recognizing the importance of sustainability for the building service contracting industry and the importance of the building service contracting industry for sustainability, taking into account the debates and outcomes of the World Congresses in Seoul and Buenos Aires and in this Congress, adopt the present communiqué.
- 2. We believe in the importance of sustainability. We subscribe to the view that sustainability is more than environmentalism; it is the integration of the three factors People, Planet and Profit. Any economic activity that does not have a positive impact on all three of these factors is not sustainable in the long term.
- The recession in the US and EU caused by the 2008 financial crisis
 presents an opportunity for a review of future activity to determine its
 sustainability and for the recovery phase of the economic cycle to prioritize
 activities to support and enhance the sustainability of the building service
 contractor sector.
- 4. Given the current position of the economic cycle, it is the right time to consider new investment in the development and promotion of sustainability for building service contractors.
- 5. Building service contractors are closely linked to sustainable development. It is a transverse sector that is linked to all other sectors; it is a trade that is largely dependent on human resources rather than capital and it is a trade that consumes energy and other resources and creates pollution. The global building service contractor agenda should reflect these realities.

Protecting the Planet

- 6. Protecting the planet is a key issue for building service contractors.
- 7. We recognize that building service contractors have the following environmental impacts
- 8. They produce waste and need to manage that waste appropriately
- 9. They use cleaning chemicals, products and equipment that impact on the environment

- 10. They consume energy and fuel that produce carbon dioxide that contributes to climate change, as well as adding costs to business.
- 11. They consume water in the delivery of their services, which is an increasingly scarce resource.
- 12. They are also positioned in the supply chain between suppliers and clients and can act to influence both parts of that chain.

Developing People

- 13. The building service contracting industry is a labour intensive sector, with workforce costs amounting to up to 80%. The social side of sustainable development is especially important in this industry.
- 14. We recognize that the building service contracting industry has the following priorities to improve its social sustainability:
- 15. The development of equal opportunities for all and the integration of disadvantaged groups into the workforce;
- 16. The improvement of work conditions to prevent accidents and reduce risks to worker health and safety
- 17. The development of employment terms and conditions that fairly reward staff
- 18. The provision of training opportunities for all staff, which may lead to formal qualifications
- 19. The recognition of workers' representatives, where appropriate
- 20. The development of partnership with clients and suppliers and external stakeholders to the building service contractor

Maximizing Profit

- 21. The building service contracting industry has suffered from low margins for many years. This has a direct and negative impact on its ability to invest in new products and services for its clients and benefits for its workers.
- 22. We recognize the following priorities for the building service contracting industry to improve its profitability.

- 23. The sector needs to grow its margins to provide a satisfactory return on investment for its capital providers
- 24. The sector should focus on reversing the "race to the bottom" and engaging in vigorous competition based on value and service and not just price alone
- 25. The sector needs to improve the quality of the work it provides and also the perception that the client base has of that work.
- 26. Building Service Contractors also need to have the business tools to enable them to quantify the business benefits of all sustainability initiatives.

Call For Action: Building Service Contractors

Recognizing the factors set out above, the building service contractors that sign this communiqué agree to undertake the following actions:

- 1. Increase the % of workers with a recognized vocational qualification
- 2. Increase the % of workers within an apprenticeship system
- 3. Increase the % of female managers and executives
- 4. Review working patterns to reduce social impacts
- 5. All workers to be trained to reduce musculoskeletal disorders
- 6. Increase the use of automatic dosing systems for cleaning machines and train workers in their proper use
- 7. Increase the use of concentrated chemicals
- 8. Reduce the volume of paper and consumables used
- 9. Use cleaning products designed for sustainability as well as safety
- 10. Reduce consumption of electricity on their own and on customer premises
- 11. Reduce volume of fuel consumed in vehicles
- 12. Increase usage of micro fibre cleaning technology
- 13. Include sustainability information in all bids for work
- 14. Include specific social and environmental criteria in all contracts with suppliers and sub-contractors
- 15. Join a recognized trade association
- 16. Publish a company sustainable development charter
- 17. Develop a risk management process for key social and environmental risks
- 18. Publish an annual report on sustainability actions
- 19. Quantify the financial benefits of the sustainability actions

Call For Action: Industry Suppliers

Recognizing the factors set out above, the building service industry suppliers that sign this communiqué agree to undertake the following actions:

- Reduce the volume of packaging used
- 2. Increase the use of concentrated chemical products
- 3. Increase the percentage of products that can be recycled
- 4. Reduce the energy consumed by cleaning machines in use
- 5. Reduce the embodied energy in their products
- 6. Quantify their carbon footprint
- 7. Work with their customers to implement the above

Call For Action: Trade Associations

Recognizing the factors set out above, the trade associations that sign this communiqué agree to undertake the following actions:

- 1. Promote sustainable development to their members
- 2. Establish member forums to ensure that discussions on sustainability are relevant and take into account member needs
- 3. Ensure that sustainability is a standing item on their Board agendas
- 4. Translate the agreements in this communiqué into their own national context.
- 5. Develop positive relationships with their Government interlocutors and will promote sustainable policies within the building service contracting sector
- Develop sustainable development projects for the benefits of their members
- 7. Seek grants available from national and supranational Governments and other funding sources to fund these projects
- 8. Collate reports from their members on their progress against their commitments under this communiqué and will provide those to the WFBSC. They will also report on their own activities.

Reporting

The WFBSC will report on the progress made against these calls for actions at its World Congress in Curitiba, Brazil, which takes place on 10 – 14 October 2012.
