2. Regulation No. 66 (Strength of superstructure)

The Working Party on General Safety Provisions (GRSG) may wish to consider any proposal on Regulation No. 66, if available.

3. Regulation No. 107 (M₂ and M₃ vehicles)

(a) Proposals for further amendments

GRSG agreed to consider:

- (i) ECE/TRANS/WP.29/GRSG/2010/33/Rev.1 by the expert from the European Commission (EC) on the accessibility of prams;
- (ii) ECE/TRANS/WP.29/GRSG/2011/3 clarifying the definition of Class II vehicles, by the expert from France;
- (iii) ECE/TRANS/WP.29/GRSG/2011/4 by the expert from the International Organization of Motor Vehicle Manufacturers (OICA) on the number of priorities seats;
- (iv) ECE/TRANS/WP.29/GRSG/2011/9 by the expert from the International Road Transport Union (IRU) on driver seats with no suspension system;
- (v) ECE/TRANS/WP.29/GRSG/2011/10 prepared by the secretariat to delete the cross reference to Regulation No. 66 with regard to the strength of superstructure.

GRSG agreed to continue consideration of ECE/TRANS/WP.29/GRSG/2010/22 by the chairman of the informal group on Camera Monitor Systems (CMS), together with the comments from OICA in ECE/TRANS/WP.29/GRSG/2011/5. GRSG also agreed to consider ECE/TRANS/WP.29/GRSG/2010/21/Rev.1 by the chairman of the CMS informal group. GRSG agreed to consider a revision of ECE/TRANS/WP.29/GRSG/2010/29 by the expert from the United Kingdom of Great Britain and Northern Ireland on blind spots on the passenger sides of N_2 and N_3 vehicles, if available. GRSG may wish to consider ECE/TRANS/WP.29/GRSG/2011/12 prepared by the expert from OICA to align the provisions concerning projections of rear view mirrors with Regulation No. 26 (External projections).
