Proposal

- 1. In Chapter 4.1, table 4.1.6
 - For "ACUTE" and "CHRONIC" read "ACUTE (SHORT-TERM AQUATIC HAZARD" and "LONG-TERM AQUATIC HAZARD" respectively
 - Replace "Category" with ""Acute" (3 times) in the table related to acute hazards, and "Category" with "Chronic" (4 times) in the table related to chronic hazards

For clarification purposes, the corrections are shown, in track changes mode, in the annex to this document.

2. In Chapter 4.1, wherever it appears in decision logics 4.1.1, and 4.1.3 (a) to (c), for "Acute Category" and "Chronic Category" read "Category"

(Applies 9 times to decision logic 4.1.1; once to decision logic 4.1.3(a); 3 times to decision logic 4.1.3 (b) and 3 times to decision logic 4.1.3 (c)

3. In Annex 1:

Justification

5. When the criteria for aquatic hazard were updated to include classification based on chronic toxicity, the terminology for sub-classes and categories was amended and corrected in the chapter. It seems, however, that the terminology in table 4.1.6 (labelling elements) and sections 4.1.5 (Decision logics), and Annexes 1 and 9, was never updated based on the changes made in the chapter. We propose that these changes be made in order to be consistent with the terminology used in Chapter 4.1.
