Hoses and hose assemblies

Note by the secretariat

At its twentieth session, the Safety Committee adopted changes to the Regulations annexed to ADN concerning the use of the words "hoses", "hose assemblies", "pipes" and "piping". The secretariat has identified some other cases in English and French where these words may need to be modified.

- 1. Page 64, 1.6.7.2.2.2, table of general transitional provisions: Tank vessels, 9.3.3.11.4 Corrected by consequential amendment in ECE/ADN/18, page 3.
- 2. Page 158, 3.2.3, explanations concerning table C, column 20, 34
 - 34. For type N carriage, the flanges and stuffing boxes of the <u>loading and unloading hoses</u> must be fitted with a protection device to protect against splashing.
- 3. Page 341, 7.2.4.25.2
- 7.2.4.25.2 The loading and unloading piping shall not be extended by <u>rigid or flexible</u> <u>pipes</u> fore or aft beyond the cofferdams.

This requirement shall not apply to <u>hoses</u> used for the reception of oily and greasy wastes resulting from the operation of vessels and the delivery of products for the operation of vessels.

Vessels shall be moored securely, but in such a way that electrical power cables and <u>flexible hoses</u> are not subject to tensile strain and the vessels can be released quickly in an emergency.
