3. Methodological development and harmonization of transport statistics

At its sixty-second session, the Working Party invited the secretariat, the representatives of France, Netherlands and Eurostat to prepare for the present session a draft of short designations at 2 digit level (ECE/TRANS/WP.6/161, para. 12) (ECE/TRANS/WP.6/2012/1).

(i) Intermodal transport statistics

The Working Party will be informed on the results of the Eurostat Task Force on intermodal transport. The cooperation between Eurostat and WP.6 on the development of intermodal transport statistics will be discussed.

Eurostat will make a presentation on this item focusing on the following topics: list of locations using UNLocodes for all modes, transport and logistics indicators (vehicle stock + infrastructure), road freight transport statistics (foreign trucks) and modal split in main ports (including the feedering).

(j) Data on reduced mobility by rail

Following the policy statement on passenger accessibility of heavy rail systems adopted by the Working Party on Rail Transport (ECE/TRANS/SC.2/212, annex III) and endorsed by the Inland Transport Committee, the Working Party on Transport Statistics has been requested to consider whether and how it could collect the data needed to quantify social benefits of accessibility measures.

The Working Party may wish to consider this issue on the basis of information to be submitted by the European Railway Agency.

(k) Relation between energy statistics and transport statistics

4. Statistical performance indicators in road safety

At its sixty-second session, the Working Party decided to have a segment on "Statistical performance indicators in road safety" during the present session. In this framework, the Working Party may wish to be informed on the EU DaCoTA (Data Collection, Transfer and Analysis) project and to exchange views on the performance indicators in road safety.

The programme of this segment will be developed further and contributions from delegates are welcome.

5. Traffic censuses in the United Nations Economic Commission for Europe region

(a) 2010 E-Road traffic census

During its seventy-third session, the Inland Transport Committee invited UNECE member States to take part in the 2010 E-Road traffic census in compliance with ITC Resolution No. 259 and urged all UNECE member States to submit the required traffic data by 1 November 2011 (ECE/TRANS/221, para. 97).

The secretariat has published the data received, as well as the previous censuses (2000 and 2005) on the WP.6 website: www.unece.org/trans/main/wp6/wp6.html.

The Working Party will be informed about the status of the 2010 E-Road traffic census (Informal document WP.6 No. 7 (2012)).

The Working Party may wish to establish an Ad hoc Group of Experts on the 2015 E-Road Traffic Census for evaluating the results of the 2010 Census, preparing recommendations to Governments on procedures and methodologies for the 2015 E-Road Traffic Census and for drafting a resolution for adoption by the UNECE Inland Transport Committee in 2014.

(b) 2010 E-Rail traffic census

During its seventy-third session, the Inland Transport Committee invited UNECE member States to take part in the 2010 E-Rail traffic census in compliance with ITC Resolution No. 260 and urged all UNECE member States to submit the required traffic data by 30 June 2012 (ECE/TRANS/221, para. 97).

The secretariat has published the previous E-Rail traffic census (2005) on the WP.6 website: www.unece.org/trans/main/wp6/wp6.html.

The Working Party may wish to establish an Ad hoc Group of Experts on the 2015 E-Rail Traffic Census for evaluating the results of the 2010 Census, preparing recommendations to

Governments on procedures and methodologies for the 2015 E-Rail Traffic Census and for drafting a resolution for adoption by the UNECE Inland Transport Committee in 2014.

6. Collection and dissemination of transport statistics by the United Nations Economic Commission for Europe

Following the adoption of the road map on collecting and disseminating of transport statistics (ECE/TRANS/WP.6/159, paras. 44–48), the secretariat published the Statistics for Road Traffic Accidents in Europe and North America (RAS) and the "UNECE Transport Statistics for Europe and North America" (former Annual Bulletin of Transport Statistics for Europe and North America (ABTS)) (see: WP.6 website: www.unece.org/transport/resources/publications/transport-statistics.html).

The Working Party may wish to consider a proposal from the Intersecretariat Working Group on Transport Statistics (IWG) aiming to split the short-RAS (short Road Accident Statistics Questionnaire) into two parts: the existing one plus missing information from CARE in particular data related to alcohol (ECE/TRANS/WP.6/2012/4, ECE/TRANS/WP.6/2012/5).
