Note by the secretariat

I. Mandate

1. The Working Party on Transport Statistics (WP.6), at its sixty-second session, invited the secretariat, the representatives of France, Netherlands and Eurostat to prepare for the present session a draft of short designations at the 2 digit level (ECE/TRANS/WP.6/161, para. 12).

2. The Working Party may wish to discuss and adopt the short descriptions contained in the table below as proposed by France and amended by the Netherlands.
