## **Proposed format of post-2015** agenda

- Based on three fundamental principles
- Four core dimensions
- Set of enablers



Need for integrated and coordinated policies to achieve progress across all dimensions

# Proposed features of post-2015 agenda

- Builds on key strengths of MDG framework with clear goals and targets
- Retains focus on key dimensions of human development
- Addresses issues that were inadequately reflected in MDGs
- Could provide general guidelines for policy orientation and coherence, without prescribing specific policies
- Should ensure flexibility to tailor targets to regional, national and subnational conditions and priorities

- Agreement by Member States at Rio+20 to launch a process to develop a set of SDGs
- 70 countries (25 from UNECE region) from the five regional groups share 30 seats
- PGA appointed Brazil, Hungary and Kenya as facilitators
- Supported by UN System Technical Support Team
- OWG will present proposal for SDGs to 68<sup>th</sup> session of GA

- Panel of 27 members to advise Secretary-General
- Co-chaired by the President of Indonesia, the President of Liberia, and the Prime Minister of the United Kingdom
- Includes leaders from civil society, private sector and government
- Panel agreed to proceed along framing questions on lessons learned from MDGs, shape and content of new framework, accountability and shaping global consensus
- Panel will submit report to SG on 31 May 2013

































**UN System** Task Team on the Post-2015 Development Agenda (UNTT)

- Over 60 UN entities and international organizations, including all Regional Commissions
- Co-chaired by UNDP and UN-DESA
- Coordinates system-wide activities
- Provides analytical inputs and recommendations
- Prepared report "Realizing the future we want for all" (2012)
- Supports OWG

## The way forward for UNECE in post-2015 process

- UNECE areas of work that will feature in post-2015 agenda will gain momentum































## Approach of draft inter-agency report on post-MDG vision for ECE region

- Inter-agency consensus to base combined vision on four areas,
   in line with proposed global format:
  - Inclusive social development
  - Inclusive economic development
  - Environmental sustainability
  - Peace, security and social stability
- In terms of stock-taking, region has made impressive progress towards
   MDGs
- Considerable challenges persist, particularly in health and environment
- Looking ahead, ECE region presents vital lessons for new global agenda
