

# 4. Implementation of the European Agreement concerning the International Carriage of Dangerous Goods by Inland Waterways (ADN)

(a) Status of ADN

The Safety Committee will be informed about the status of ADN.

(b) Special authorizations, derogations and equivalents

The Safety Committee may wish to discuss the request by the Netherlands for the issuance of a temporary derogation regarding the use of diesel and liquefied natural gas as fuel for the *Eiger Nordwand* (Informal document INF.3).

(c) Interpretation of the Regulations annexed to ADN

The Safety Committee is invited to discuss document ECE/TRANS/WP.15/AC.2/2014/30 on submerged motors for LNG systems on inland navigation vessels.

The Safety Committee is invited to discuss the interpretation of any provisions of the Regulations annexed to ADN which are considered to be ambiguous or unclear.

(d) Training of experts

The Safety Committee may wish to consider the report of the twelfth meeting of the informal working group on the training of experts (19-20 March 2014) (ECE/TRANS/WP.15/AC.2/2014/49).

(e) Matters related to classification societies.

The list of classification societies recognised by ADN Contracting Parties can be found at the following link: www.unece.org/trans/danger/publi/adn/adnclassifications.html. No new recognitions of classification societies have been notified to the secretariat since the last session of the Safety Committee.

A Committee of Experts appointed by the ADN Administrative Committee met to consider the application of the Registro Italiano Navale for recognition as a Recommended ADN Classification Society. The results of that meeting are contained in ECE/TRANS/WP.15/AC.2/2014/36.

A request by DNV GL SE is contained in ECE/TRANS/WP.15/AC.2/2014/37.

#### 5. Proposals for amendments to the Regulations annexed to ADN

(a) Work of the RID/ADR/ADN Joint Meeting

The Safety Committee may wish to consider the work of the RID/ADR/ADN Joint Meeting at its spring 2014 session (ECE/TRANS/WP.15/AC.1/134 and Adds.1 and 2).

The Safety Committee may also wish to consider the report of the Working Party on the Transport of Dangerous Goods (WP.15) on its ninety-sixth session (ECE/TRANS/WP.15/224) and the additional list of proposed amendments to ADR adopted for entry into force on 1 January 2015 which are contained in ECE/TRANS/WP.15/222/Corr.1 and ECE/TRANS/WP.15/222/Add.1.

The proposed amendments that are relevant for ADN in the above-mentioned documents are presented in ECE/TRANS/WP.15/AC.2/2014/35.

The Safety Committee may wish to refer to the consolidated list of amendments to ADN adopted for entry into force on 1 January 2015 (ECE/ADN/27) which will be notified to ADN Contracting Parties on 1 July 2014.

Any proposals for additional amendments and corrections to ECE/ADN/27 resulting from the present session and adopted by the ADN Administrative Committee for entry into force on 1 January 2015 will be presented in documents ECE/ADN/27/Add.1 and ECE/ADN/27/Corr.1.

Additional proposed amendments aimed at bringing ADN into line with other international agreements on the carriage of dangerous goods have to be communicated to Contracting Parties no later than 1 September 2014 in accordance with the procedure outlined in article 20, paragraph 5 (a) of ADN, to ensure their entry into force on 1 January 2015, i.e. one month after acceptance by Contracting Parties.

Proposed corrections have to be communicated to Contracting Parties on 1 October 2015 (date of acceptance of the amendments in ECE/ADN/27) for acceptance in accordance with the usual procedure for corrections so that they can become effective at the latest by 1 January 2015.
