Note by the secretariat

I. Mandate

- 1. This document is submitted in line with cluster 5: Inland Waterway Transport, paragraph 5.1 of the programme of work 2014–2015 (ECE/TRANS/2014/23) adopted by the Inland Transport Committee on 27 February 2014 (ECE/TRANS/240).
- 2. The secretariat may remind the Working Party (ECE/TRANS/240) that the Working Party on the Standardization of Technical and Safety Requirements in Inland Navigation (SC.3/WP.3) at its forty-seventh session, approved several amendments to Resolution No. 57 (ECE/TRANS/SC.3/WP.3/94, para. 44).
- 3. The Working Party on Inland Water Transport may wish to consider and adopt these amendments, presented below (chapter II).

- 5. Delete paragraph 1.5 (i)



- 6. Renumber existing paragraph 1.5 (j) as 1.5 (i)
- 7. Add paragraphs 1.5 (j) and 1.5 (k) as follows
 - (j) UNECE Resolution No. 79 on International Standards for Electronic Ship Reporting in Inland Navigation (ECE/TRANS/SC.3/198);
 - (k) UNECE Resolution No. 80 on International Standards for Notices to Skippers in Inland Navigation (ECE/TRANS/SC.3/199).

Replace in paragraph 4.3.6 (d) "UNECE Resolution No. 60 on International Standards for Notices to Skippers and for Electronic Ship Reporting in Inland Navigation (ECE/TRANS/SC.3/175 as amended)" by "UNECE Resolution No. 79 on International Standards for Electronic Ship Reporting in Inland Navigation (ECE/TRANS/SC.3/198)"
- Replace in paragraph 4.4.3 (d) "UNECE Resolution No. 60 on International Standards for Notices to Skippers and for Electronic Ship Reporting in Inland Navigation (ECE/TRANS/SC.3/175 as amended)" by "UNECE Resolution No. 79 on International Standards for Electronic Ship Reporting in Inland Navigation (ECE/TRANS/SC.3/198)"
- Replace in paragraph 4.5.2 (c) "UNECE Resolution No. 60 on International Standards for Notices to Skippers and for Electronic Ship Reporting in Inland Navigation (ECE/TRANS/SC.3/175 as amended)" by "UNECE Resolution No. 80 on International Standards for Notices to Skippers in Inland Navigation (ECE/TRANS/SC.3/199)"
- 11. Replace in paragraph 4.7.1 (b) (ii) "Regional Arrangement Concerning the Radiotelephone Service on Inland Waterways (Europe, 06.04.2000)" by "Regional Arrangement on the Radiocommunication Service for Inland Waterways (RAINWAT), Bucharest, 18 April 2012, as amended on 3 April 2013".
