2. Promotion of River Information Services (RIS) as well as other Information and Communication Technologies (ICT) in inland navigation

(a) Workshop "River Information Services and other information communication technologies in the pan-European format"

According to the decision of its forty-eighth session (ECE/TRANS/SC.3/WP.3/96, para. 47), member States, River Commissions, the European Union (EU), Chairs of River Information Services (RIS) Expert Groups and invited organizations may wish to share best practices, recent developments and policies in this field, discuss on how to ensure better coordination and synergy in implementation and promotion of RIS and other information and communication technologies in inland navigation at a pan-European level. The participants may wish to consider the discussion paper prepared by the secretariat (ECE/TRANS/SC.3/WP.3/2016/9). The Working Party will be informed about the results of RIS Week (13–17 June 2016, Prague).

The Working Party may wish to make recommendations to the Working Party on Inland Water Transport (SC.3) on further UNECE activities in this field following Policy Recommendation No. 3 of the UNECE White Paper on Efficient and Sustainable Inland Water Transport in Europe.

4. Harmonization of the pan-European legal framework for inland navigation

The Working Party will continue discussion of reactions of Contracting Parties to the International Convention on Registration of Inland Navigation Vessels, River Commissions and other stakeholders on possible modification of Article 3 of the Convention which could cause implications for their regulatory frameworks. SC.3/WP.3 may wish to propose recommendations for further consideration by SC.3.

(b) Budapest Convention on the Contract for the Carriage of Goods by Inland Waterway (CMNI) and Strasbourg Convention on Limitation of Liability in Inland Navigation (CLNI)

The Working Party will be informed about the outcome of the eighth Colloquium organized by the International Association for the Rhine Ships Register (IVR) (17–18 March 2016, Bonn, Germany) dedicated to the developments in the international field of limitation of liability and the carriage of goods and passengers on inland waterways, in particular, CMNI, CLNI 2012 and other issues. The Working Party may wish to exchange opinions or give comments on this matter.

5. Inland waterways infrastructure

(a) European Agreement on Main Inland Waterways of International Importance (AGN)

The Working Party will be informed by the secretariat about the current status of the European Agreement on Main Inland Waterways of International Importance and the progress made on its implementation. The Working Party may also wish to discuss further cooperation with the Working Party on Intermodal Transport and Logistics.

The Working Party may wish to consider draft amendments to the Inventory of Main Standards and Parameters of the E Waterway Network ("Blue Book") as presented in ECE/TRANS/SC.3/WP.3/2016/12.

The secretariat will inform the Working Party about the progress of the third revision of the Blue Book and the outcome of consultations with the Danube Commission on the parameters of E 80 waterway (ECE/TRANS/SC.3/WP.3/96, para. 20). SC.3/WP.3 may wish to discuss and approve the second draft of the third revision of the Blue Book. Governments are invited to submit amendments to the Blue Book for discussion and approval by SC.3/WP.3.

The Working Party will be informed by the International Commission on the E 40 Waterway Restoration about the progress reached in the development of the Dnipro-Vistula section of the E 40 waterway (ECE/TRANS/SC.3/WP.3/2016/13).

Member States and other stakeholders are invited to report on current progress in any other inland waterway infrastructure development projects.

6. Standardization of technical and safety requirements in inland navigation

(a) European Code for Inland Waterways (CEVNI) (Resolution No. 24, revised)

The Working Party may wish to consider the proposal of the Central Commission for the Navigation on the Rhine on new articles to be added to the CEVNI on the basis of the newly introduced provisions for vessels using Liquefied Natural Gas (LNG) as a fuel and other proposals as reproduced in ECE/TRANS/SC.3/WP.3/2016/14.

SC.3/WP.3 may wish to take note of the information submitted by member States and River Commissions for the CEVNI status document and the questionnaire on regional and national special requirements.

The Working Party will be further informed about the progress in preparing the text of CEVNI in German, after consultations with the Danube Commission, and availability of other language versions.

The Working Party may wish to take note of the poster on inland waterway signs and signals based on the fifth revised edition of CEVNI prepared by the Serbian Directorate for Inland Waterways (PLOVPUT) in collaboration with the secretariat in English, French and Russian.
