## I. Mandate

1. This document is submitted in line with cluster 5: Inland Waterway Transport, para. 5.1 of the programme of work 2016-2017 (ECE/TRANS/2016/28/Add.1) adopted by the Inland Transport Committee at its seventy-eighth session on 26 February 2016.

2. It is recalled that the Working Party on Inland Water Transport (SC.3), at its sixtieth session, had decided to start preparations of a package of amendments to the European Agreement on Main Inland Waterways of International Importance (AGN) (ECE/TRANS/SC.3/203, para. 34) and had asked the secretariat to prepare the first draft of amendments for the consideration by the Working Party on the Standardization of Technical and Safety Requirements in Inland Navigation (SC.3/WP.3).

Reproduced below is a set of draft amendments to Annexes I and II to AGN as provisionally approved by SC.3/WP.3 at its fiftieth and fifty-first sessions (ECE/TRANS/SC.3/WP.3/100, para. 9, and ECE/TRANS/SC.3/WP.3/102, para. 9), SC.3 may wish to consider and formally adopt the draft amendments as reflected in this document and request the secretariat to transmit them to the depositary.
