(b) Classification system for transport statistics

(c) Common questionnaire

The Working Party may wish to be informed about the availability of data collected through the common questionnaire for transport statistics.

(d) Road traffic accident statistics and rail traffic accident statistics

The Working Party may wish to be informed about the availability of data on road traffic accidents.

The Working Party may wish to consider the collection of the main indicators on rail traffic accidents (ECE/TRANS/WP.6/2016/4), and be informed on the progress on the pilot rail safety questionnaire that was sent out by the secretariat in February 2017 (ECE/TRANS/WP.6/2017/3).

The Working Party will be informed on the availability of statistics on accidents at level crossings.
