










## Requirements for 5 stars Adult Occupant protection.



- Encourage public and private motor vehicle fleet operators in Africa, including the UN's own fleet managers, to adopt Global NCAP fleet safety guidelines6 which recommend the purchase of vehicles that exceed a crash test rating minimum of four stars and pass the most important UN vehicle regulations.


