The text reproduced below was prepared by IWG SLR on the basis of document ECE/TRANS/WP.29/GRE/2018/11, as adopted at the seventy-ninth session of the Working Party on Lighting and Light-Signalling (GRE), with the aim to further improve and clarify the proposal to introduce transitional provisions in the existing UN Regulations on lighting and light-signalling in conjunction with the introduction of three new simplified UN Regulations on Light-Signalling Devices (LSD), Road Illumination Devices (RID) and The modifications Retro-Reflective Devices (RRD). to the text of ECE/TRANS/WP.29/GRE/2018/11, as adopted by GRE, are marked in bold for new or strikethrough for deleted characters.

II. Justification

1. At its sevety-ninth session, GRE adopted the transitional provisions as proposed in ECE/TRANS/WP.29/GRE/2018/11, but decided to put in square brackets the third transitional provision for each UN Regulation mentioned in the document.

2. IWG SLR has carefully reconsidered this proposal, taking into account the discussion at the GRE session, and agreed to produce a revised proposal to improve and clarify the transitional provisions.

3. In this revised proposal the following changes have been made to the adopted text of ECE/TRANS/WP.29/GRE/2018/11:

- (a) Removal of square brackets around 24 months value for the transitional period.
- (b) The third transitional provision for each Regulation mentioned in the document has been removed and the subsequent paragraphs have been renumbered accordingly.
