2. Transport Infrastructure Construction costs: Presentations of good practices at national levels for evaluating and calculating them

The members of the Group will discuss models, methodologies, tools and good practices for evaluating, calculating and analyzing inland transport infrastructure construction costs that have been implemented at national and possibly at international levels.

The Group may wish to recall that at its previous session discussed that Chapter two of its final report should include all methodologies and good practices already presented by the experts as well as additional information that might be provided by the ECE member States. Furthermore, the secretariat kindly requested the experts to provide a two pages summary of their presentations in order to incorporate them in the chapter. Also, the secretariat informed the group that will undertake a desktop analysis to collect all relevant publicly available information.

The Group also recalled the proposal made by the International Road Federation (IRF) at its previous session on including in this chapter guidelines with main principles for the Governments that they would like to prepare a new tool / methodology to evaluate and calculate those costs.

The Group may wish to review and consider Informal Document No. 1 which includes the draft Chapter 2 of its final report.

3. Transport Infrastructure Construction costs: Presentations of terminologies used

The Group may wish to recall that at its previous session considered informal documents No. 3 and No. 4 provided by the representative of PKP Polish Railway Lines (PKP PLK) on railways terminologies and questionnaire. Also, during that session the Group decided that PKP PLK should take the lead of railways sub-group in close cooperation with the International Union of Railways (UIC). The subgroup should prepare a first draft of both the list of terminologies and the questionnaire for the next session of the Group in May. The

Group may wish to review and consider Informal Document No. 2 which includes the draft terminology and questionnaire for railways sector.

Regarding the Inland Waterways sector the Group during its last session reviewed document ECE/TRANS/WP.5/GE.4/2018/3 which included draft terminologies for the sector. The Group may wish to recall that the secretariat informed the Group that this document would be uploaded as informal document for the fifty-third session of the working party on the standardization of technical and safety requirements in inland navigation (27–29 June 2018) for their review and consideration.

On ports the Group may wish to recall that the port of Gdynia had undertaken the lead of ports subgroup and had already prepared for Group last session draft list of terminologies, as well as a draft questionnaire for the benchmarking study. The Group may wish to review Informal Document No. 3 which includes the draft list of terminologies and the questionnaire for ports construction costs.

4. Transport Infrastructure Construction Costs: Overview of main concerns and considerations

The Group's Terms of Reference stipulates the submission of a full report of its accomplishments, including policy-oriented recommendations.
