

# intermodal transport terminals

#### INLAND TRANSPORT COMMITTE

(a) Mapping intermodal transport terminals

- A study is under preparation (secretariat with UIRR and Europlatforms)
- Focus on mapping and categorizing the types of terminals that exist in the UNECE region and on the available facilities
- Will consider UIRR study on transparency in rail facility information and practices to be completed in course of 2019





#### INLAND TRANSPORT COMMITTE

(b) Preparation of national master plans on freight transport and logistics

- Master plans on freight transport and logistics are key to strengthening the sector and so the national economies
- A handbook on national master plans on freight transport and logistics under development
- Structure of the handbook agreed in November 2018
- Advanced draft expected for November 2019

- Collection of information on the use of the CTU Code
- Search for solutions to make the CTU Code easily accessible (mobile application)

- Agreement on the review of CTU Code
- Role for a Group of Experts on the CTU Code (in cooperation with IMO and ILO)
- Request to ITC to approve the establishment of the Group for Experts based on Terms of Reference (ECE/TRANS/2019/14)

- Continuation of monitoring and analysis of national measures to promote intermodal transport
- 2019 collection of information

- Contribution to EATL work on intermodal issues

# **Workshop 2018** "Operational challenges of regional intermodal transport and innovative solutions"

Rationale:

- Intermodal Transport can help achieve goals of the 2030 Agenda for Sustainable Development since intermodality leads to economic, environmental and social sustainability
- To do so, different operational challenges that intermodal transport faces and which can vary between regions have to be identified and addressed
